WHEREAS, The quintessential civic leader, Mary Luckern has been Supervisor of the Town of Geneva since 1998, the first woman ever elected to that post; she is also a member of the Ontario County Board of Supervisors, she serves as the Ontario County representative on the Tourism Board, and is a presence on the Ontario County Economic Development Committee; and
