WHEREAS, For nearly 35 years, John H. Ciulla Jr. rendered faithful, conscientious and valuable service to the Saratoga County Public Defender's Office, earning the admiration, esteem and affection of his colleagues; and

WHEREAS, John H. Ciulla Jr. is widely respected as an accessible and committed defender, whose steady hand, even temper and quiet but determined work ethic will be missed by all; and

WHEREAS, In his capacity as Saratoga County Public Defender, John H. Ciulla Jr. served with loyalty, honor and distinction, and always showed a unique grasp of human problems in his official acts; and

WHEREAS, With him throughout have been his wife, Linda, and their daughters, Lisa Ann and Jennifer, all of whom feel privileged to be a part of his life and rejoice in his achievements; and
