WHEREAS, When Nadia Finkelstein's youngest child was in school full-time, she returned to the Albany Home for Children which eventually became Parsons Child and Family Center; she remained there for 23 years until her retirement; her responsibilities at the Albany Home began as Residential Team Coordinator, then Director of Residential Care and finally as Associate Executive Director of the agency; and

WHEREAS, The Parsons Child and Family Center allowed Nadia Finkelstein time to lead workshops nationally, write several articles in professional journals and finally author CHILDREN AND YOUTH IN LIMBO, A SEARCH FOR CONNECTIONS, published by Praeger; and

WHEREAS, Nadia Finkelstein's most proud accomplishment was being an active participant in the moving of Parsons Child and Family Center from a child centered agency with three professional programs including residential, day treatment and education, to becoming a family centered agency with an array of 32 programs and services committed to the importance of family connections in a young person's life; and

WHEREAS, With her throughout have been her three children and five grandchildren, all of whom feel privileged to be a part of her life and rejoice in her achievements; and

WHEREAS, Nadia Finkelstein has continually demonstrated extreme competence, extraordinary intelligence and diligent leadership in her unwavering service to her community and profession; and
