WHEREAS, Amy Dacey has been called upon to contribute her time and talents to countless civic and charitable endeavors and has always given of herself unstintingly; and

WHEREAS, She currently serves as Chairwoman of the Board of the American Council of Young Political Leaders (ACYPL), a nonpartisan non-governmental organization internationally recognized as the pre-eminent catalyst for introducing rising political and policy professionals to international affairs, and to each other; and

WHEREAS, Amy Dacey earned a bachelor's degree in Political Science and History from the State University of New York at Binghamton in 1993, and a master's degree in Political Science from the American University in Washington, D.C. in 1995; and
