WHEREAS, The active duty United States Army career of Michael Daughtry began in 1967; he was assigned to the 101st Airborne Division, D Company, 1st Battalion, 501st infantry; and

WHEREAS, Michael Daughtry deployed to Vietnam in December 1967; he was seriously wounded in action in mid-1967, and spent one and a half years recuperating from his wounds in St. Alban's Hospital in Queens, New York; and

WHEREAS, During his distinguished military service, Michael Daughtry was awarded the Purple Heart, Bronze Star Medal, Army Commendation Medal, Combat Infantry Badge, Parachute Badge, Good Conduct Medal, Vietnam Service Medal, Vietnam Cross of Gallantry, Vietnam Presidential Unit Citation and National Defense Medal; and

WHEREAS, Michael Daughtry worked for General Motors for 32 years until his retirement five years ago; and

WHEREAS, Michael Daughtry and his wife of 46 years, Diane, are the proud parents of three children; and

WHEREAS, Throughout the entire period of his military, professional and community service, a period of constructive involvement, Michael Daughtry has stood constant in dignity, good grace and humor, and has earned the respect and admiration of his colleagues, family and friends; and

WHEREAS, Our veterans deserve to be recognized, commended and thanked by the people of the State of New York for their service and for their dedication; now, therefore, be it
