WHEREAS, The firefighters of New York State are renowned throughout the Nation; their reputation is synonymous with excellence in the arduous field of fire protection and prevention; and

WHEREAS, Since the early days of "teapot steamers," the volunteer firefighter has been the cornerstone of our great State's efforts to spare us from the ravages of fire; and

WHEREAS, This distinguished Veteran also served as a Machinist Mate, 2nd Class, in the United States Navy onboard USS Braine (DD-630), a Fletcher class destroyer; he is a life member of the American Legion; and

WHEREAS, Service to the community was an established practice within his family; his father joined the Lakewood Fire Company in 1939; and his mother was a charter member of the Ladies Auxiliary; his three brothers were also members of the fire company, and two of his sisters served in the auxiliary; and

WHEREAS, A devoted family man, Edwin N. Nelson, Jr. and his wife raised five children; many of his children and grandchildren continued the family tradition of volunteering with the fire service; his daughter, Linda, and his grandson, Colten, continue to actively serve with the Lakewood Fire Company; and

WHEREAS, It takes a special dedication, a strong desire to help others and a tireless sense of community to forsake precious time with family and friends to respond to the signal that a neighbor is in need; now, therefore, be it
