WHEREAS, Programs such as the Dutchess County Regional Chamber of Commerce Think Pink for Breast Cancer Awareness event play an important role in combating the disease through providing education, resources, and funds towards finding a cure; and

WHEREAS, It is the sense of this Legislative Body that when associations of such noble aims and accomplishments are brought to our attention, they should be celebrated and recognized by all the citizens of this great Empire State; now, therefore, be it
