WHEREAS, His philanthropic and civic activities include: aiding distressed communities plagued by drugs and gangs, mentoring youth, negotiating truces between rival street gang factions in New York and

Washington, DC; he has served on the boards of directors of the United

Way, Rockland County; International Rotary Club; and Mock Youth Courts; he also assisted the President and Tribal Council of the Lakota Sioux Tribes at the Rosebud Reservation in South Dakota; and

WHEREAS, In addition, Anthony Mele serves as the Chairman, 65th Infantry Regiment Honor Task Force, where for the past 14 years, he has worked on a national scale for the recognition and rights of veterans, ranging from ensuring they receive an appropriate military honor guard funeral service, lost decorations or overlooked awards due them, and serving as their voice in providing testimony before government officials; this compassionate man also visits his fellow veterans in hospitals; and
