WHEREAS, Jessica Burgos-Diaz is enrolled in the Basic Office Medical Procedures Program and has been accepted for a Medical Technology Program at Jamestown Community College; she works doubly hard to translate medical terms from English to Spanish and back again during her coursework; and

WHEREAS, With a focus on her future, Jessica Burgos-Diaz plans to volunteer at WCA Hospital until she finishes her schooling; and

WHEREAS, There are many remarkable stories in the world of adult education, but few are as impressive as that of Jessica Burgos-Diaz, who serves as an inspiration to us all; now, therefore, be it
