- AN ACT to amend the public health law, in relation to the permitting requirements for children's camps; and to repeal certain provisions of such law relating thereto

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 1391 of the public health law, as added by chapter 2 515 of the laws of 2000, is amended to read as follows:

S 1391. Declaration of public policy. It is the declared policy of the state of New York to protect the health, safety and welfare of children tending what are commonly called children's overnight, summer day, [and] traveling summer day, AND SINGLE-PURPOSE DAY camps.

7 S 2. Section 1392 of the public health law is amended by adding a new 8 subdivision 5 to read as follows:

5. "SINGLE-PURPOSE DAY CAMP" SHALL MEAN A PROPERTY CONSISTING OF 9 Α 10 TRACT OF LAND AND ANY TENTS, VEHICLES, BUILDINGS OR OTHER STRUCTURES THAT MAY BE PERTINENT TO ITS USE, ANY PART OF WHICH MAY BE OCCUPIED ON A 11 12 SCHEDULED BASIS AT ANY TIME BETWEEN JUNE FIRST AND SEPTEMBER FIFTEENTH 13 INANY YEAR BY CHILDREN UNDER SIXTEEN YEARS OF AGE UNDER GENERAL SUPER-VISION, FOR THE PURPOSE OF A SINGLE INDOOR OR OUTDOOR ORGANIZED 14 GROUP INVOLVING A NONPASSIVE RECREATIONAL ACTIVITY WITH SIGNIFICANT 15 ACTIVITY, RISK OF INJURY, AS SUCH ACTIVITIES ARE DEFINED BY 16 THE DEPARTMENT IN 17 RULES REGULATIONS, FOR A PERIOD OF LESS THAN TWENTY-FOUR HOURS ON AND 18 ANY DAY THE PROPERTY IS SO OCCUPIED, AND ON WHICH NO PROVISIONS ARE MADE FOR OVERNIGHT OCCUPANCY BY SUCH CHILDREN. THE COMMISSIONER SHALL 19 HAVE TO EXCEPT BY RULE FROM THIS ARTICLE AND THE SANITARY CODE A 20 THE POWER

S 3. Section 1392-a of the public health law is REPEALED.

4 S 4. Section 1393 of the public health law, as added by chapter 515 of 5 the laws of 2000, subdivision 4 as amended by chapter 439 of the laws of 6 2009, is amended to read as follows:

7 S 1393. Permit requirements. 1. No person, firm, corporation, or asso-8 ciation shall operate a children's overnight, summer day, [or] traveling 9 summer day, OR SINGLE-PURPOSE DAY camp without first obtaining a permit 10 from an officer.

2. An officer shall issue a permit if, after inspection, the chil-11 12 dren's overnight, summer day, [or] traveling summer day, OR SINGLE-PUR-POSE DAY camp is in compliance with this chapter and the sanitary code. 13 14 All permits shall expire one year from the date of issuance of such 15 permit or upon such earlier date as specified by such officer which date 16 shall in no event be earlier than the latest date that such camps may 17 remain open pursuant to regulations prescribed by the commissioner. Nothing in this section shall be construed to limit the responsibilities 18 and duties of compliance arising out of any other provision of law. 3. Notwithstanding any other provision of law, an officer in issuing a 19

20 21 permit may waive any requirement of the sanitary code setting a minimum 22 standard of floor space per camper in a camp's sleeping quarters. Such a 23 waiver may be granted upon written application therefor, and shall be 24 accompanied by a statement by the officer of the specific terms and 25 conditions under which the waiver shall have been granted. Such waivers 26 may be granted only to camps constructed prior to January first, nine-27 teen hundred seventy-five. An officer shall grant such waiver where the 28 application therefor is accompanied by a written certification by the local health officer of its need or desirability to avoid an immediate 29 undue hardship upon the operator which may result in the closing of the 30 children's overnight camp to prospective campers, and a statement by the 31 32 local health officer that the granting of a waiver shall not present a 33 hazard to public health and safety. All such waivers shall expire on December thirty-first of the year in which they are granted, but may be 34 35 renewed for good and sufficient reason.

4. The fee for a permit [shall be two hundred dollars, except that 36 no 37 shall be charged in the case of a children's overnight, summer day fee 38 or traveling summer day camp operated by a person, firm, corporation or 39 association for charitable, philanthropic or religious purposes] FOR A 40 FOR-PROFIT CHILDREN'S OVERNIGHT, SUMMER DAY, TRAVELING SUMMER OR DAY SINGLE-PURPOSE DAY CAMP SHALL BE AS FOLLOWS: CAMPS WITH A MAXIMUM CAPAC-41 42 TWO HUNDRED CHILDREN DURING A SINGLE SESSION SHALL BE THREE ITY OF HUNDRED DOLLARS, CAMPS WITH A MAXIMUM CAPACITY OF THREE HUNDRED CHILDREN 43 44 DURING A SINGLE SESSION SHALL BE FIVE HUNDRED DOLLARS, CAMPS WITH Α 45 MAXIMUM CAPACITY OF FIVE HUNDRED CHILDREN DURING A SINGLE SESSION SHALL BE SEVEN HUNDRED DOLLARS, AND CAMPS WITH A MAXIMUM CAPACITY 46 EXCEEDING 47 CHILDREN DURING A SINGLE SESSION SHALL BE ONE THOUSAND HUNDRED FIVE 48 DOLLARS. THE FEE FOR A NOT-FOR-PROFIT CHILDREN'S OVERNIGHT, SUMMER DAY, 49 TRAVELING SUMMER DAY, OR SINGLE-PURPOSE DAY CAMP SHALL BE TWO HUNDRED 50 DOLLARS. THE FEES SET FORTH IN THIS SUBDIVISION SHALL EXCLUSIVELY GOVERN 51 ALL CHILDREN'S OVERNIGHT, SUMMER DAY, TRAVELING SUMMER DAY, AND SINGLE-PURPOSE DAY CAMP NOTWITHSTANDING THE PROVISIONS OF ANY OTHER LAW TO THE 52 CONTRARY, AND SHALL PREEMPT ANY LOCAL LAW OR REGULATION REQUIRING THE 53 54 PAYMENT OF ANY ADDITIONAL FEE TO INSPECT, PERMIT, OR OPERATE ALL OR ANY 55 PART OF A CHILDREN'S OVERNIGHT, SUMMER DAY, TRAVELING SUMMER DAY OR SINGLE-PURPOSE DAY CAMP EXCEPT AS EXPRESSLY SET FORTH IN THIS SECTION. 56

5. Any enrollment application forms and/or enrollment contract forms 1 2 mailed or delivered to a person for purposes of enrollment of a child any children's overnight, summer day, [or] traveling summer day, OR 3 for 4 SINGLE-PURPOSE DAY camp shall contain or be accompanied by a written 5 statement which declares: 6 that such camp is required to be licensed by the [New York state] (a) 7 department [of health]; 8 (b) that [such camp is required to be inspected twice yearly] CHIL-9 DREN'S OVERNIGHT, SUMMER DAY, TRAVELING SUMMER DAY OR SINGLE-PURPOSE DAY 10 CAMPS ARE REQUIRED TO BE INSPECTED BY THE DEPARTMENT IN ACCORDANCE WITH 11 SECTION THIRTEEN HUNDRED NINETY-THREE-A OF THIS ARTICLE; [and] 12 (c) the address where inspection reports concerning such camp are 13 filed[.]; AND 14 (D) THAT SUCH CAMP IS REQUIRED TO PURCHASE LIABILITY INSURANCE. 15 S 5. The public health law is amended by adding a new section 1393-a 16 to read as follows: S 1393-A. INSPECTION REQUIREMENTS. 1. CHILDREN'S OVERNIGHT 17 CAMPS ARE REOUIRED TO BE INSPECTED TWICE YEARLY. CHILDREN'S SUMMER DAY CAMPS AND 18 19 TRAVELING SUMMER DAY CAMPS ARE REQUIRED TO BE INSPECTED ONCE PER YEAR. 20 CHILDREN'S SINGLE-PURPOSE DAY CAMPS ARE REQUIRED TO BE INSPECTED AT 21 LEAST ONCE EVERY OTHER YEAR. 22 2. NOTWITHSTANDING ANY OTHER PROVISION OF LAW, THE DEPARTMENT MAY WAIVE ONE ANNUAL INSPECTION FOR ANY CHILDREN'S OVERNIGHT, SUMMER DAY, OR 23 SUMMER DAY CAMP. IN CONTEMPLATION OF SUCH WAIVER, THE DEPART-24 TRAVELING 25 MENT SHOULD GIVE PRIORITY TO CAMPS THAT ARE ACCREDITED BY THE AMERICAN 26 CAMP ASSOCIATION, CAMPS THAT HAVE NO RECORD OF OUTBREAKS, INCIDENTS OR 27 SAFETY PROBLEMS, CAMPS THAT HAVE BEEN RESPONSIVE TO THE DEPARTMENT'S 28 CAMPS WITH EXPERIENCED LEADERSHIP STAFF, SMALLER CAMPS, AND REQUESTS, 29 CAMPS THAT OFFER MORE LOW-RISK ACTIVITIES. S 6. Section 1394 of the public health law, as added by chapter 515 of 30 the laws of 2000, subdivision 3 as added by chapter 214 of the laws of 31 2012, is amended to read as follows: 32 33 Children's camps; standards and regulations. 1. The public S 1394. 34 health council shall prescribe standards and establish regulations for children's overnight, summer day [and], traveling summer day, AND 35 SINGLE-PURPOSE DAY camps, as defined in this article, concerning such 36 37 matters as may be appropriate for the protection and security of the 38 life, health and safety of the occupants of such camps. 39 2. All buses or other motor vehicles which are owned by a traveling 40 summer day camp or which are operated or leased by such camp for the purpose of transporting children attending such camp shall meet the 41 requirements for safe operation of such vehicles as provided for in 42 43 section one hundred forty of the transportation law. 44 3. Any person, firm, corporation, or association that operates a chil-45 dren's overnight, summer day, [or] traveling summer day, OR SINGLE-PUR-POSE DAY camp, and has obtained a permit pursuant to section thirteen 46 47 hundred ninety-three of this article, shall be authorized to employ or 48 contract with a physician, nurse practitioner, physician assistant, registered nurse, or licensed practical nurse or emergency medical tech-49 50 nician to act as a designated camp health director or to provide health 51 services in assistance to the camp health director pursuant to applicable regulations promulgated by the commissioner. 52 S 7. Section 1394-a of the public health law, as amended by chapter 53 54 428 of the laws of 2008, is amended to read as follows: 55 1394-a. Requirement to check sex offender registry. Every person, S 56 firm, limited liability company, association and corporation which oper1 ates a CHILDREN'S OVERNIGHT, summer day, TRAVELING SUMMER DAY, OR 2 SINGLE-PURPOSE DAY camp shall be required, to ascertain whether an 3 employee or volunteer is listed on the state sex offender registry 4 pursuant to article six-C of the correction law prior to the day such 5 employee or volunteer commences work at said camp and annually thereaft-6 er prior to their arrival at said camp.

7 S 8. Section 1395 of the public health law, as added by chapter 515 of 8 the laws of 2000, is amended to read as follows:

9 S 1395. Violations; temporary restraining order. 1. A violation of 10 this chapter or of the sanitary code in the operation of a children's 11 overnight, summer day, [or] traveling summer day, OR SINGLE-PURPOSE DAY 12 camp shall constitute a public nuisance which may be enjoined or 13 restrained.

14 2. When an officer has cause to believe that there has been a 15 violation of this chapter or the sanitary code in the operation of a children's overnight, summer day, [or] traveling summer day, OR SINGLE-16 17 PURPOSE DAY camp which does not constitute a public health hazard as 18 defined by the sanitary code, and that such violation has continued for 19 more than three days after notice of the violation and demand for 20 discontinuance and abatement thereof has been served in writing on the 21 children's overnight, summer day, [or] traveling summer day, OR SINGLE-22 PURPOSE DAY camp operator in the manner prescribed for the service of summons set forth in the civil practice law and rules, an officer may: 23

(a) Conduct a hearing upon at least three days notice served on the camp operator in the manner prescribed for the service of summons as set forth in the civil practice law and rules, and

27 (b) Make a determination after such hearing with respect to the 28 alleged violation or violations and have the power to assess a fine on 29 the children's overnight, summer day, [or] traveling summer day, OR 30 SINGLE-PURPOSE DAY camp operator not to exceed two hundred fifty dollars 31 for each violation for each day succeeding the third day after the 32 notice of violation and demand for discontinuance and abatement thereof 33 has been given, and

34 (c) With respect to the hearing set forth herein the officer in 35 accordance with the civil practice law and rules may: issue subpoena, 36 compel the attendance of witnesses, and administer oaths to witnesses, 37 and

38 (d) Make an ex parte application to the supreme court of the state of 39 New York for a temporary restraining order which the court may grant 40 when it determines that there is a violation which requires immediate 41 relief.

When an officer has cause to believe that there has been a 42 3. 43 violation of this chapter or the sanitary code in the operation of A 44 children's overnight, summer day, [or] traveling summer day, OR SINGLE-45 PURPOSE DAY camp which constitutes a public health hazard as defined by the sanitary code, and after notice of the violation has been served in 46 47 writing on the children's overnight, summer day, [or] traveling summer 48 day, OR SINGLE-PURPOSE DAY camp operator in the manner prescribed for 49 the service of summons set forth in the civil practice law and rules, an 50 officer may:

51 (a) Conduct a hearing upon at least fifteen days notice in accordance 52 with the provisions of section twelve-a of this chapter served on the 53 camp operator in the manner prescribed for the service of summons as set 54 forth in the civil practice law and rules, and

55 (b) Make a determination after such hearing with respect to the 56 alleged violation or violations and have the power to assess a fine on 1

4 (c) With respect to the hearing set forth herein the officer in 5 accordance with the civil practice law and rules may: issue A subpoena, 6 compel the attendance of witnesses, and administer oaths to witnesses, 7 and

8 (d) Make an ex parte application to the supreme court of the state of 9 New York for a temporary restraining order which the court may grant 10 when it determines that there is a violation which requires immediate 11 relief.

4. The officer may appoint one or more hearing officers as shall be necessary to do or perform in his place or stead the acts authorized by paragraphs (a) and (c) of subdivision two of this section. The hearing officer shall make findings of fact and submit recommendations to the officer.

5. An officer may institute proceedings to enjoin the continuance of such violation or the continued operation of such camp. No bond or undertaking shall be required of such officer in such proceedings and no application to vacate or modify any judgment obtained shall be entertained by any court without proof to such court that ten days notice of such application, and copies of the papers upon which the application is to be made, have been served upon such officer.

Nothing contained in this section shall be construed to limit the 24 6. 25 duty or power of an officer to act with regard to an immediate threat to the health of the occupants of a children's overnight, summer day, [or] 26 traveling summer day, OR SINGLE-PURPOSE DAY camp or the community in 27 which it is located, or to alter or abridge any of the duties and powers 28 29 now or hereafter existing in the commissioner, state district health officers, county boards of health, county commissioners of health or 30 local boards of health. 31

32 7. Nothing contained in this section shall be construed to limit or 33 preclude the officer from enforcing or pursuing any remedies or penalties available under this chapter or sanitary code with respect to violations which constitute a public health hazard as defined by the 34 35 sanitary code, in the operation of the children's overnight, summer day, 36 37 [or] traveling summer day, OR SINGLE-PURPOSE DAY camp, including, but limited to, those remedies or penalties available under sections 38 not 39 twelve, sixteen, two hundred six, two hundred twenty-nine, three hundred 40 nine, and three hundred forty-eight of this chapter.

41 S 9. This act shall take effect 1 year after it shall have become a 42 law.
