Introduced by Sens. SERRANO, ADDABBO, KRUEGER, MONTGOMERY, PARKER, STAVISKY -- read twice and ordered printed, and when printed to be committed to the Committee on Education

ACT to amend the education law, in relation to directing the commissioner of education to conduct an audit and report on statewide compliance with state instructional regulations for arts education

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

- Section 1. The education law is amended by adding a new section 816 to 1 read as follows:
 - S 816. ARTS INSTRUCTION COMPLIANCE. 1. THE COMMISSIONER AUTHORIZED AND REQUIRED TO COLLECT THE NECESSARY DATA AND INFORMATION TO ASSESS COMPLIANCE WITH STATE EDUCATION REGULATIONS FOR ARTS INSTRUCTION AT ALL SCHOOLS THROUGHOUT THE STATE ONCE EVERY FIVE YEARS. THE BOARD OF EDUCATION OR TRUSTEES OF ALL SCHOOL DISTRICTS SHALL COMPLY WITH REQUESTS BY THE DEPARTMENT FOR SUCH INFORMATION AS IS DEEMED RELEVANT BY DEPARTMENT.
 - THEINITIAL ASSESSMENT REOUIRED BY THE PROVISIONS OF THIS SECTION SHALL BE CONDUCTED AND REPORTED TO THE LEGISLATURE AND THE PUBLIC JUNE, TWO THOUSAND FOURTEEN FOR THE TWO THOUSAND THIRTEEN--TWO THOUSAND FOURTEEN SCHOOL YEAR AND EVERY FIVE YEARS THEREAFTER.
- 3. ONCE A DISTRICT HAS BEEN FOUND TO BE COMPLIANT WITH THE STATE EDUCATION REGULATIONS FOR ARTS INSTRUCTION, THE COMMISSIONER SHALL NOT BE REOUIRED TO ASSESS OR EVALUATE THAT DISTRICT'S LEVEL OF COMPLIANCE AS PROVIDED IN SUBDIVISION ONE OF THIS SECTION OR TO INCLUDE 17 INFORMATION DISTRICT'S COMPLIANCE WITH STATE EDUCATION REGULATIONS 18 THECONCERNING 19 FOR ARTS INSTRUCTION IN THE REPORT TO THE LEGISLATURE AND THE PUBLIC AS 20 PROVIDED IN SUBDIVISION TWO OF THIS SECTION.
- 21 S 2. This act shall take effect immediately.
