THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivisions 3 and 11 of section 120.05 of the penal law, 2 as amended by chapter 259 of the laws of 2013, are amended to read as 3 follows:

With intent to prevent a peace officer, a police officer, prosecu-4 5 tor as defined in subdivision thirty-one of section 1.20 of the criminal б procedure law, registered nurse, licensed practical nurse, sanitation 7 enforcement agent, New York city sanitation worker, a firefighter, 8 including a firefighter acting as a paramedic or emergency medical tech-9 nician administering first aid in the course of performance of duty as 10 such firefighter, an emergency medical service paramedic or emergency medical service technician, or medical or related personnel in a hospi-11 12 tal emergency department, a city marshal, A SCHOOL CROSSING GUARD 13 APPOINTED PURSUANT TO SECTION TWO HUNDRED EIGHT-A OF THE GENERAL MUNICI-14 PAL LAW, a traffic enforcement officer or traffic enforcement agent, from performing a lawful duty, by means including releasing or failing 15 16 control an animal under circumstances evincing the actor's intent to
