- AN ACT to amend the executive law and the state finance law, in relation to requiring reports by state agencies relating to certain grants and expenditures made to community based organizations

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 164 of the executive law, as amended by chapter 833 2 of the laws of 1965, is amended to read as follows:

S 164. Reports by and to the department. 3 1. Each department, other than the executive department, shall make an annual report to the gover-4 5 and legislature on or before the fifteenth day of May, for the nor 6 preceding calendar year. It shall contain such information concerning the department and its several divisions, bureaus, offices, agencies and 7 8 institutions, and their activities and affairs, and such recommenda-9 tions, as the head of the department shall deem necessary or proper, and 10 any matters required by express provision of law to be included in such report. A department also shall make such other and special reports as 11 the governor or either house of the legislature may require. 12 From time 13 to time, the head of a department may require from any board, commission 14 other body in the department or from any subordinate officer or or employee, division or bureau of the department, or from any institution 15 subject to the supervision of the department, or from any agency of the 16 department, such reports or information as such head may deem necessary. 17 Unless expressly authorized by the head of the department, 18 there shall 19 hereafter no separate report, annual or otherwise, directly to the be 20 legislature or governor by any such board, commission, body, officer, 21 division, bureau, institution or agency notwithstanding any existing 22 provision of law authorizing or requiring such report.

IN ADDITION TO THE ANNUAL REPORT REQUIRED BY THIS SECTION, THE THE BUDGET SHALL MAKE A REPORT TO THE LEGISLATURE BY MARCH 2 DIVISION OF 3 FIRST OF EACH YEAR RELATING TO DISTRIBUTION OF FUNDS AND GRANTS TO 4 COMMUNITY BASED ORGANIZATIONS AND SUCH REPORT SHALL BE POSTED ON THE 5 DIVISION OF THE BUDGET WEBSITE IN A MANNER WHICH IS CLEAR AND ACCESSIBLE 6 SUCH REPORT SHALL PROVIDE A LISTING OF RECIPIENTS, BY ТΟ THE PUBLIC. 7 ZIP CODE, OF GRANTS, AWARDS OR FUNDS APPROPRIATED FOR SERVICES AND 8 PROGRAMS WHICH ARE MADE TO ORGANIZATIONS WHICH PROVIDE SERVICES ON A 9 LOCAL BASIS PURSUANT TO PROGRAMS ESTABLISHED BY LAW.

10 S 2. Section 14 of the state finance law, as amended by chapter 155 of 11 the laws of 2012, is amended to read as follows:

S 14. Departmental statements. 1. In addition to the annual department 12 reports prescribed by law, the head of each department of the state, on 13 14 or before the fifteenth day of October in each year, shall submit to the 15 governor a statement of the sources, amounts and disposition of all 16 money received by such department, its divisions, bureaus or officers 17 the preceding fiscal year other than money appropriated for such for 18 department by the legislature or money that was paid by such department into the treasury. Such statement shall include a description of the 19 nature and the amount of each fund, if any, then under the supervision 20 21 control of such department or the head thereof or under the superor 22 vision or control of any division, bureau, commission, board or other organization therein or under the supervision or control of the head or 23 any other officer of such division, bureau, commission, board or organ-24 25 ization, which was derived from any source whether or not deposited in the treasury, a citation of the statute authorizing the creation or 26 establishment of each such fund and the nature and amount of any 27 28 payments made therefrom during the preceding fiscal year. The director 29 the budget in the executive department shall make rules, which shall of be approved by the governor, regulating the form and contents of such 30 statements. Copies of such statements shall be simultaneously furnished 31 32 to the senate finance committee and the assembly ways and means commit-33 tee for their information.

34 2. The governor, in such form and with such explanation as the gover-35 nor may desire, shall transmit to the legislature, with the annual budget, a recapitulation or summary of the information contained 36 in such 37 statements arranged under appropriate headings for each department. The 38 provisions of this section shall not apply to any funds received by the 39 superintendent of financial services in a fiduciary capacity or to the 40 state teachers' retirement fund, or any state employees' retirement and pension fund, but such exemption from the application of this section 41 shall not affect any other provision of law requiring a report or state-42 43 ment of such funds.

44 3. IN ADDITION TO THE ANNUAL REPORT REQUIRED BY THIS SECTION, THE 45 THE BUDGET SHALL MAKE A REPORT TO THE LEGISLATURE BY MARCH DIVISION OF FIRST OF EACH YEAR RELATING TO DISTRIBUTION OF FUNDS 46 AND GRANTS TO 47 COMMUNITY BASED ORGANIZATIONS AND SUCH REPORT SHALL BE POSTED ON THE 48 DIVISION OF THE BUDGET WEBSITE IN A MANNER WHICH IS CLEAR AND ACCESSIBLE 49 TO THE PUBLIC. SUCH REPORT SHALL PROVIDE A LISTING OF RECIPIENTS, ΒY 50 CODE, GRANTS, AWARDS OR FUNDS APPROPRIATED FOR SERVICES AND ZIP OF PROGRAMS WHICH ARE MADE TO ORGANIZATIONS WHICH PROVIDE 51 SERVICES ON A LOCAL BASIS PURSUANT TO PROGRAMS ESTABLISHED BY LAW. 52
