AN ACT to amend the tax law, in relation to increasing the tax credit provided for solar energy system equipment

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Paragraph 1 of subsection (g-1) of section 606 of the tax law, as amended by chapter 375 of the laws of 2012, is amended to read as follows:

- (1)General. An individual taxpayer shall be allowed a credit against 5 the tax imposed by this article equal to twenty-five percent of qualified solar energy system equipment expenditures, except as provided in 7 subparagraph (D) of paragraph two of this subsection. This credit shall not exceed three thousand seven hundred fifty dollars for qualified 8 solar energy equipment placed in service before September first, 9 thousand six, and five thousand dollars for qualified solar energy 10 equipment placed in service on or after September first, two thousand six AND PRIOR TO SEPTEMBER FIRST, TWO THOUSAND THIRTEEN, AND TEN THOU-11 12 13 SAND DOLLARS FOR QUALIFIED SOLAR ENERGY EQUIPMENT PLACED IN SERVICE ON 14 OR AFTER SEPTEMBER FIRST, TWO THOUSAND THIRTEEN.
- 15 S 2. This act shall take effect immediately and shall apply to taxable 16 years commencing on and after January 1, 2013.
