- AN ACT to amend the retirement and social security law, in relation to certain disabilities of environmental police officers

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Section 363-a of the retirement and social security law, as amended by chapter 967 of the laws of 1974, subdivision 3 as amended by chapter 357 of the laws of 2002 and subdivision 4 as amended by chapter for the laws of 1975, is amended to read as follows:

[Firemen and policemen] FIREFIGHTERS AND POLICE OFFICERS; 5 363-a. S б certain disabilities. 1. Notwithstanding any provision of this chapter 7 of any general, special, or local law to the contrary, any condition or of impairment of health caused by diseases of the heart, resulting in 8 9 disability or death to a [fireman] FIREFIGHTER shall be presumptive 10 evidence that it was incurred in the performance and discharge of duty 11 and the natural and proximate result of an accident, unless the contrary 12 be proved by competent evidence.

13 Notwithstanding any provision of this chapter or of any general, 2. 14 special, or local law to the contrary, any condition of impairment of health caused by diseases of the heart, resulting in disability or death 15 16 a [policeman] POLICE OFFICER, presently employed, and who shall have to 17 sustained such disability while so employed, shall be presumptive evidence that [is] IT was incurred in the performance and discharge of 18 19 duty, unless the contrary be proved by competent evidence.

3. As used in this section, the [term "fireman" and "policeman" means] TERMS "FIREFIGHTER" AND "POLICE OFFICER" MEAN any member who is performing police or fire service, as the phrase police or fire service is defined in paragraphs a, b, c, d, F (AS ADDED BY CHAPTER SIX HUNDRED

SEVENTY-FOUR OF THE LAWS OF NINETEEN EIGHTY-SIX), F (AS ADDED BY CHAPTER 1 SIX HUNDRED SEVENTY-SEVEN OF THE LAWS OF NINETEEN EIGHTY-SIX), g, and h 2 3 subdivision eleven of section three hundred two of this article, and of 4 who, prior to entry into service as a [fireman or policeman] FIREFIGHTER 5 OR POLICE OFFICER, successfully passed a physical examination which 6 failed to disclose evidence of any disease or other impairment of the 7 heart.

8 The provisions of this section shall remain in full force and 4. 9 effect to and including August thirty-first, nineteen hundred seventy-10 six.

S 2. The amendments made to section 363-a of the retirement and social 11 12 security law by section one of this act shall not affect, impair, or invalidate any temporary right, privilege, or benefit conferred pursuant 13 to the provisions of a general, special or local law (other than pursu-14 15 ant to articles 14 and 15 of the retirement and social security law) for 16 any member of a public retirement system or pension plan funded by the state or one of its political subdivisions, nor shall any amendments 17 thereto affect the application of such provisions as extended by the 18 19 provisions of section 480 of the retirement and social security law. 20

S 3. This act shall take effect immediately.

FISCAL NOTE. -- Pursuant to Legislative Law, Section 50:

This bill would amend the Retirement and Social Security Law in relation to heart disease related disabilities. It would add a "heart bill" provision for police officers of the Division of Law Enforcement the Department of Environmental Conservation who are members of the in New York State and Local Police and Fire Retirement System.

If this bill is enacted, it could lead to more disabilities being classified as "performance of duty". We anticipate that few performance duty disability retirements will be granted, and thus, the resulting costs will be negligible.
