- AN ACT to amend the alcoholic beverage control law and the vehicle and traffic law, in relation to authorizing courts to suspend a driver's license where the holder fails to appear before the court, pay a fine, complete an alcohol awareness program or complete community service within the period of time established by such court

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 3 of section 65-c of the alcoholic beverage 2 control law, as amended by chapter 137 of the laws of 2001, is amended 3 to read as follows:

4 3. Any person who unlawfully possesses an alcoholic beverage with 5 intent to consume may be summoned before and examined by a court having б jurisdiction of that charge; provided, however, that nothing contained 7 herein shall authorize, or be construed to authorize, a peace officer as in subdivision thirty-three of section 1.20 of the criminal 8 defined 9 procedure law or a police officer as defined in subdivision thirty-four section 1.20 of such law to arrest a person who unlawfully possesses 10 of an alcoholic beverage with intent to consume. If a determination is made 11 sustaining such charge the court may impose a fine not exceeding fifty 12 dollars and/or completion of an alcohol awareness program established pursuant to section 19.25 of the mental hygiene law and/or an appropri-13 14 15 ate amount of community service not to exceed thirty hours. 1 FINE, COMPLETE AN ALCOHOL AWARENESS PROGRAM OR COMPLETE COMMUNITY 2 SERVICE PURSUANT TO THIS SECTION WITHIN THE PERIOD OF TIME ESTABLISHED 3 BY SUCH COURT. SUCH SUSPENSION SHALL BE MADE UPON NOTICE TO SUCH PERSON 4 AND SHALL REMAIN IN EFFECT UNTIL SUCH PERSON APPEARS IN COURT, SUCH FINE 5 HAS BEEN PAID OR SUCH PROGRAM OR COMMUNITY SERVICE HAS BEEN COMPLETED TO 6 THE SATISFACTION OF THE COURT.

7 S 2. Paragraph k of subdivision 3 of section 510 of the vehicle and 8 traffic law, as amended by chapter 124 of the laws of 1992, is amended 9 and a new paragraph l is added to read as follows:

10 k. for a period of up to ninety days because of the conviction of the 11 holder of the offenses of menacing as defined in section 120.15 of the 12 penal law, where such offense was committed against a traffic enforce-13 ment agent employed by the city of New York or the city of Buffalo while 14 such agent was enforcing or attempting to enforce the traffic regu-15 lations of such city[.];

16 L. FOR FAILING TO APPEAR BEFORE THE COURT OR PAY A FINE OR TO COMPLETE 17 AN ALCOHOL AWARENESS PROGRAM OR COMPLETE COMMUNITY SERVICE IMPOSED BY 18 THE COURT PURSUANT TO SUBDIVISION THREE OF SECTION SIXTY-FIVE-C OF THE 19 ALCOHOLIC BEVERAGE CONTROL LAW.

20 S 3. Paragraph (a) of subdivision 4-a of section 510 of the vehicle 21 and traffic law, as added by section 10 of part J of chapter 62 of the 22 laws of 2003, is amended to read as follows:

23 (a) Upon receipt of a court notification of the failure of a person to 24 appear within sixty days of the return date or new subsequent adjourned 25 date, pursuant to an appearance ticket charging said person with a 26 violation of any of the provisions of this chapter (except one for parkstopping, or standing), of any violation of the tax law or OF 27 inq, SUBDIVISION THREE OF SECTION SIXTY-FIVE-C OF THE ALCOHOLIC 28 BEVERAGE 29 CONTROL LAW OR of the transportation law regulating traffic or of any lawful ordinance or regulation made by a local or public authority, 30 relating to traffic (except one for parking, stopping, or standing) or 31 32 the failure to pay a fine imposed by a court the commissioner or his or 33 agent may suspend the driver's license or privileges of such person her 34 pending receipt of notice from the court that such person has appeared in response to such appearance ticket or has paid such fine. Such 35 suspension shall take effect no less than thirty days from the day upon 36 37 which notice thereof is sent by the commissioner to the person whose 38 driver's license or privileges are to be suspended. Any suspension issued pursuant to this paragraph shall be subject to the provisions of 39 40 paragraph (j-1) of subdivision two of section five hundred three of this [chapter] TITLE. 41

42 S 4. This act shall take effect on the first of January next succeed-43 ing the date on which it shall have become a law.
