AN ACT to amend the village law, in relation to including a high school member on village boards of trustees

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Paragraph b of subdivision 1 of section 3-301 of the 2 village law is amended to read as follows:

- b. four trustees, except that the board of trustees of a village may change the number of trustees as authorized by section 3-304 of this article, AND EXCEPT THAT THE BOARD OF TRUSTEES OF A VILLAGE MAY APPOINT ONE STUDENT REPRESENTATIVE TO SUCH BOARD AS AUTHORIZED BY SECTION 3-305 OF THIS ARTICLE;
- S 2. The village law is amended by adding a new section 3-305 to read as follows:
- 10 S 3-305 STUDENT REPRESENTATIVE. THE BOARD OF TRUSTEES BY RESOLUTION 11 LOCAL LAW MAY APPOINT ONE STUDENT REPRESENTATIVE TO SUCH BOARD. SUCH STUDENT REPRESENTATIVE SHALL BE A SENIOR IN A HIGH SCHOOL OF A SCHOOL 12 13 DISTRICT IN WHICH ALL OR PART OF SUCH SCHOOL DISTRICT IS CONTAINED WITH-THE TERM OF SUCH STUDENT REPRESENTATIVE SHALL BE FOR 14 SUCH VILLAGE. ONE YEAR AND SHALL BEGIN ON THE JULY FIRST PRECEDING THE SENIOR YEAR OF 15 SUCH STUDENT REPRESENTATIVE AND END THE FOLLOWING JUNE THIRTIETH. A 16 17 VACANCY OF SUCH REPRESENTATIVE MAY BEFILLEDBY THEBOARD FOR OF SUCH TERM. SUCH STUDENT REPRESENTATIVE SHALL BE ENTITLED TO SIT WITH BOARD MEMBERS AT ALL PUBLIC MEETINGS 19 OF THE BOARD AND AND MEETINGS, PROVIDED THAT SUCH 20 PARTICIPATE IN ALL BOARD HEARINGS
