- AN ACT to amend the penal law, in relation to unlawful surveillance in the first and second degrees

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 250.45 of the penal law, as added by chapter 69 of 2 the laws of 2003, subdivisions 1, 2 and 3 as amended by chapter 157 of the laws of 2003, is amended to read as follows: 3 4

S 250.45 Unlawful surveillance in the second degree.

5 A person is guilty of unlawful surveillance in the second degree when: 6 1. For his or her own, or another person's amusement, entertainment, 7 or profit, or for the purpose of degrading or abusing a person, he or 8 intentionally uses or installs, or permits the utilization or she installation of an imaging device to surreptitiously view, broadcast or 9 10 record a person dressing or undressing or the sexual or other intimate parts of such person OR ENGAGING IN SEXUAL CONDUCT, AS DEFINED IN SUBDI-11 12 VISION TEN OF SECTION 130.00 OF THIS CHAPTER, at a place and time when 13 such person has a reasonable expectation of privacy, without such 14 person's knowledge or consent; or

15 2. For his or her own, or another person's sexual arousal or sexual gratification, he or she intentionally uses or installs, or permits the 16 utilization or installation of an imaging device to surreptitiously 17 18 view, broadcast or record a person dressing or undressing or the sexual 19 or other intimate parts of such person OR ENGAGING IN SEXUAL CONDUCT, AS 20 DEFINED IN SUBDIVISION TEN OF SECTION 130.00 OF THIS CHAPTER, at a place

and time when such person has a reasonable expectation of privacy, with-1 2 out such person's knowledge or consent; or

3 (a) For no legitimate purpose, he or she intentionally uses or 3. 4 installs, or permits the utilization or installation of an imaging 5 device to surreptitiously view, broadcast or record a person in a bedroom, changing room, fitting room, restroom, toilet, bathroom, washб 7 room, shower or any room assigned to quests or patrons in a motel, hotel 8 or inn, without such person's knowledge or consent.

(b) For the purposes of this subdivision, when a person uses or 9 10 installs, or permits the utilization or installation of an imaging device in a bedroom, changing room, fitting room, restroom, toilet, 11 bathroom, washroom, shower or any room assigned to guests or patrons in 12 13 a hotel, motel or inn, there is a rebuttable presumption that such person did so for no legitimate purpose; or 14

15 4. Without the knowledge or consent of a person, he or she inten-16 tionally uses or installs, or permits the utilization or installation of 17 imaging device to surreptitiously view, broadcast or record, under an the clothing being worn by such person, the sexual or other intimate 18 19 parts of such person OR A PERSON ENGAGING IN SEXUAL CONDUCT, AS DEFINED 20 IN SUBDIVISION TEN OF SECTION 130.00 OF THIS CHAPTER. 21

Unlawful surveillance in the second degree is a class E felony.

22 S 2. Section 250.55 of the penal law, as added by chapter 69 of the laws of 2003, is amended to read as follows: 23

S 250.55 Dissemination of an unlawful surveillance image in the second 24 25 degree.

26 A person is guilty of dissemination of an unlawful surveillance image 27 in the second degree when he or she, with knowledge of the unlawful 28 conduct by which an image or images of the sexual or other intimate parts of another person or persons OR OF A PERSON ENGAGING IN SEXUAL 29 CONDUCT, AS DEFINED IN SUBDIVISION TEN OF SECTION 130.00 OF THIS 30 CHAP-TER, were obtained and such unlawful conduct would satisfy the essential 31 32 elements of the crime of unlawful surveillance in the first or second 33 degree, intentionally disseminates such image or images.

34 Dissemination of an unlawful surveillance image in the second degree 35 is a class A misdemeanor.

36 3. Section 250.60 of the penal law, as added by chapter 69 of the S 37 laws of 2003, subdivisions 1 and 2 as amended by chapter 157 of the laws 38 of 2003, is amended to read as follows:

39 S 250.60 Dissemination of an unlawful surveillance image in the first 40 degree.

A person is guilty of dissemination of an unlawful surveillance image 41 in the first degree when: 42

43 1. He or she, with knowledge of the unlawful conduct by which an image or images of the sexual or other intimate parts of another person or 44 45 persons OR OF A PERSON ENGAGING IN SEXUAL CONDUCT, AS DEFINED IN SUBDI-VISION TEN OF SECTION 130.00 OF THIS CHAPTER, were obtained and such 46 47 unlawful conduct would satisfy the essential elements of the crime of 48 unlawful surveillance in the first or second degree, sells or publishes 49 such image or images; or

50 Having created a surveillance image in violation of section 250.45 2. 51 or 250.50 of this article, or in violation of the law in any other jurisdiction which includes all of the essential elements of either such 52 crime, or having acted as an accomplice to such crime, or acting as an 53 54 agent to the person who committed such crime, he or she intentionally disseminates such unlawfully created image; or 55

5 Dissemination of an unlawful surveillance image in the first degree is 6 a class E felony.

7 S 4. This act shall take effect on the first of November next succeed-8 ing the date on which it shall have become a law.
