## TITLE 6

THE 21ST CENTURY WORKGROUP FOR DISEASE ELIMINATION AND REDUCTION SECTION 266. THE 21ST CENTURY WORKGROUP FOR DISEASE ELIMINATION AND REDUCTION.

- 266. 21ST CENTURY WORKGROUP FOR DISEASE ELIMINATION AND THEREDUCTION. THE21ST CENTURY WORKGROUP FOR DISEASE ELIMINATION AND REDUCTION IS HEREBY CREATED WITHIN THE DEPARTMENT. THE WORKGROUP SHALL:
- 1. BE COMPRISED OF EXPERTS WITHIN THE DEPARTMENT'S BUREAU OF IMMUNIZA-TION, EXPERTS ON THE IMMUNIZATION ADVISORY COUNCIL AND OTHER EXPERTS THE COMMISSIONER DEEMS APPROPRIATE, CHARGED WITH THE MISSION OF EXISTING VACCINES, THE STATUS OF INTERNATIONAL RESEARCH AND DEVELOPMENT FOR VACCINES LIKELY TO BE CANDIDATES FOR THE PHARMACEUTICAL MARKETPLACE, AND TO REVIEW THE STATUS OF HEALTH THREATS WHICH COULD BE ADDRESSED BY THE DEVELOPMENT OF VACCINES;
- 2. STUDY THE SEVERITY, FREQUENCY OF OCCURRENCE, LIKELIHOOD OF RECUR-RENCE, EXISTING ANIMAL VACCINES AND POTENTIAL HUMAN VACCINES FOR TUBER-CULOSIS, EASTERN EOUINE ENCEPHALITIS VIRUS, LYME DISEASE, HUMAN IMMUNO-19 DEFICIENCY VIRUS, AND ANY OTHER DISEASE OR VIRUS THE COMMISSIONER 20 APPROPRIATE;
- 22 3. CONSULT WITH NATIONAL VACCINE AND IMMUNIZATION POLICY MAKING ORGAN-23 IZATIONS, INCLUDING BUT NOT LIMITED TO, THE ADVISORY COMMITTEE ON IMMUN-24 IZATION PRACTICES UNDER THE CENTERS FOR DISEASE CONTROL AND PREVENTION,

- 5. REPORT ANNUALLY TO THE COMMISSIONER, THE TEMPORARY PRESIDENT OF THE 6 SENATE, THE SPEAKER OF THE ASSEMBLY, THE CHAIR OF THE SENATE STANDING 7 COMMITTEE ON HEALTH, AND THE CHAIR OF THE ASSEMBLY HEALTH COMMITTEE.
- 8 S 2. This act shall take effect immediately.
