- AN ACT to amend the executive law, in relation to the establishment of the New York state veterans cemetery act

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

1 Section 1. Short title. This act shall be known and may be cited as 2 the "New York state veterans cemetery act".

3 S 2. The executive law is amended by adding a new section 369 to read 4 as follows:

5 S 369. VETERANS CEMETERY PROGRAM. THE DIVISION IS HEREBY DIRECTED TO 6 CONDUCT AN INVESTIGATION AND STUDY ON THE ISSUE OF THE ESTABLISHMENT OF 7 A NEW YORK STATE VETERANS CEMETERY PROGRAM WHICH WILL BE A BENEFICIAL ACCEPTABLE SOLUTION FOR SERVING THE VETERANS OF THE STATE. 8 AS SOON AND AS POSSIBLE AFTER THE COMMENCEMENT OF SUCH STUDY, 9 THE DIVISION SHALL 10 SUBMIT TO THE FEDERAL VETERANS ADMINISTRATION CEMETERY GRANTS PROGRAM A PRE-APPLICATION FOR THE ESTABLISHMENT OF ONE OR MORE VETERANS 11 CEME-INVESTIGATION AND STUDY SHALL BE COMPLETED ON OR BEFORE 12 TERIES. SUCH 13 DECEMBER THIRTY-FIRST, TWO THOUSAND THIRTEEN. WITHIN NINETY DAYS OF THE COMPLETION OF SUCH INVESTIGATION AND STUDY, THE DIVISION WHICH WILL BE A 14 BENEFICIAL AND ACCEPTABLE SOLUTION FOR SERVING THE VETERANS OF THE STATE 15 16 SHALL COMPLETE AND DELIVER, TO THE CHAIR OF THE SENATE COMMITTEE ON 17 VETERANS, HOMELAND SECURITY AND MILITARY AFFAIRS AND THE CHAIR OF THE 18 ASSEMBLY COMMITTEE ON VETERANS' AFFAIRS A REPORT ON SUCH INVESTIGATION STUDY, CONTAINING RECOMMENDATIONS TO THE LEGISLATURE ON THE ESTAB-19 AND LISHMENT OF A NEW YORK STATE VETERANS CEMETERY PROGRAM. SUCH RECOMMENDA-20 TIONS SHALL INCLUDE WHAT MEASURES NEED TO BE TAKEN BY 21 THIS STATE TΟ 22 ESTABLISH SUCH A PROGRAM, WHAT LAWS SHOULD BE AMENDED OR ADDED TO ESTAB-23 LISH SUCH A PROGRAM, AND WHAT FISCAL RESOURCES WOULD NEED TO BE APPRO-24 PRIATED AND EXPENDED, IF ANY, TO ESTABLISH SUCH A PROGRAM. 25

S 3. This act shall take effect immediately.
