AN ACT to amend the education law, in relation to eligibility for senior high school athletic competition

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

- Section 1. The education law is amended by adding a new section 3208-b to read as follows:
- ELIGIBILITY FOR SENIOR HIGH SCHOOL ATHLETIC COMPETITION; 3208-B. DISABILITY EXCEPTION. THE COMMISSIONER SHALL PROMULGATE REGULATIONS WAIVER OF THE FOUR-YEAR LIMITATION ON ELIGIBILITY FOR SENIOR HIGH SCHOOL ATHLETIC COMPETITION WHEN A STUDENT WITH A DEVELOPMENTAL 7 PHYSICAL DISABILITY, WHO IS OTHERWISE QUALIFIED TO COMPETE AND HAS BEEN 8 SELECTED FOR SUCH COMPETITION IN THE PAST, HAS NOT YET GRADUATED 9 SCHOOL. THE COMMISSIONER SHALL DEFINE DEVELOPMENTAL OR PHYSICAL DISABIL-
- 10 ITY FOR PURPOSES OF THIS WAIVER IN ACCORDANCE WITH PART 200 OF THE COMMISSIONER'S REGULATIONS. SUCH WAIVER SHALL BE REQUESTED 11
- ATHLETIC DIRECTOR OF SUCH STUDENT'S SCHOOL AND THE SUPERINTENDENT OF 12
- SUCH SCHOOL'S DISTRICT AND MAY BE 13 GRANTED BY SUCH SCHOOL DISTRICT'S
- 14 SECTION OF THE NEW YORK STATE PUBLIC HIGH SCHOOL ATHLETIC ASSOCIATION.
- SUCH WAIVER SHALL ONLY ALLOW PARTICIPATION ON AN UNOFFICIAL, NON-SCORING 15 BASIS IN A NON-CONTACT OR NON-COLLISION SPORT, 16 PROVIDED THAT ANOTHER
- 17 OUALIFIED STUDENT, WHO IS OTHERWISE ELIGIBLE FOR COMPETITION, IS NOT
- DENIED THE OPPORTUNITY TO PARTICIPATE. 18
