AN ACT to amend the education law, in relation to the conservation and preservation of library research materials program

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1.     Subdivision 7 of section 273 of the education law, as  
2 amended by section 3 of part O of chapter 57 of the laws of 2005, is  
3 amended to read as follows:  
4     7. Conservation and preservation of library research materials. a. The  
5 commissioner shall award, BY JULY FIRST in any state fiscal year, an  
6 annual FORMULA grant of one hundred [twenty-six] FIFTY-EIGHT thousand  
7 dollars for a program of conservation and/or preservation of library  
8 research materials to each of the following comprehensive research  
9 libraries: Columbia university libraries, Cornell university libraries,  
10 New York state library, New York university libraries, university of  
11 Rochester libraries, Syracuse university libraries, the research  
12 libraries of the New York public library, state university of New York  
13 at Albany library, state university of New York at Binghamton library,  
14 state university of New York at Buffalo library, and state university of  
15 New York at Stony Brook library.  
16     b. To be eligible for such FORMULA grants, each such comprehensive  
17 research library must submit both a five-year plan and an annual program  
18 budget. The plan must satisfy criteria to be established by the commis-  
19 sioner in regulations relating to the identification of library research  
20 materials, the need for their preservation, and the means of their  
21 conservation.

1 VISION FOR THE NEW YORK STATE LIBRARY IN THE STATE OPERATIONS BUDGET  
2 SHALL BE EQUAL TO AND NOT LESS THAN THE APPROPRIATION AMOUNT PROVIDED  
3 FOR EACH OF THE OTHER COMPREHENSIVE RESEARCH LIBRARIES IN THE STATE  
4 LOCAL ASSISTANCE BUDGET.

5 c. [Additional grants, the sum of which shall not exceed three hundred  
6 fifty thousand dollars in any state fiscal year, may be made to any or  
7 all of the eleven comprehensive research libraries for preservation  
8 and/or conservation of library research materials on the basis of  
9 project proposals. Approval of such proposals, and determination of  
10 funding level, shall be based upon their contribution to development of  
11 cooperative programs and/or facilities for conservation and/or preserva-  
12 tion works in the state, including but not limited to such factors as:  
13 institutional commitment to development of a collective capacity and  
14 coordinated approach to conservation and preservation of research mate-  
15 rials important to the people of the state; research value of materials  
16 to be preserved and/or conserved; appropriateness of conservation and  
17 preservation techniques in accordance with statewide planning and  
18 national standards; institutional capacity for successful completion of  
19 the project, including facilities, experience, and technical expertise;  
20 availability of staff with appropriate training and expertise; contrib-  
21 ution of the institution to the project in matching funds and staff  
22 resources; and volume of interlibrary lending and access to holdings by  
23 the public. Ninety percent of each such grant shall be payable upon  
24 approval by the department and the remaining ten percent shall be paya-  
25 ble upon project completion.

26 d.] Other agencies and libraries, as defined in regulations promulgat-  
27 ed by the commissioner, which are not eligible for funding under para-  
28 graph a of this subdivision, may receive separate grants the sum of  
29 which shall not exceed five hundred thousand dollars in any state fiscal  
30 year to support the preservation and/or conservation of unique library  
31 research materials. Such agencies and libraries shall submit proposals  
32 which shall be evaluated and determinations of approval and funding  
33 shall be made [on the same basis set forth in paragraph c of this subdi-  
34 vision]. Ninety percent of each such grant shall be payable upon  
35 approval by the department and the remaining ten percent shall be paya-  
36 ble upon project completion.

37 [e.] D. Funds made available under the provisions of this section may  
38 be used by comprehensive research libraries and other agencies eligible  
39 for funding to obtain matching funds from the national endowment for the  
40 humanities preservation program.

41 [f.] E. The commissioner shall establish an office for coordination of  
42 conservation and/or preservation of library research materials to iden-  
43 tify the conservation and/or preservation needs of libraries within the  
44 state, to assess the technology available for such conservation and  
45 preservation, and to coordinate the conservation and preservation  
46 efforts resulting from this legislation.

47 S 2. This act shall take effect immediately and shall be deemed to  
48 have been in full force and effect on and after April 1, 2013; provided,  
49 however, that the amendments made to paragraphs a and c of subdivision 7  
50 of section 273 of the education law by section one of this act shall  
51 take effect April 1, 2014.
