AN ACT to amend the town law and the public officers law, in relation to authorizing town justices in the town of Piercefield, in the county of St. Lawrence, to reside outside such town

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- Section 1. Section 23 of the town law is amended by adding a new subdivision 26 to read as follows:
 - 26. NOTWITHSTANDING THE PROVISIONS OF SUBDIVISION ONE OF THIS SECTION, IN THE TOWN OF PIERCEFIELD, IN THE COUNTY OF ST. LAWRENCE, THE PERSONS PERFORMING THE FUNCTIONS OF TOWN JUSTICE NEED NOT BE ELECTORS OF SUCH TOWN. PROVIDED, HOWEVER, THE PERSONS PERFORMING THE FUNCTIONS OF TOWN JUSTICE IN ANY OTHER TOWN SHALL BE ELECTORS OF SUCH TOWN UNLESS OTHERWISE PROVIDED BY LAW.
- 9 S 2. Section 3 of the public officers law is amended by adding a new 10 subdivision 60 to read as follows:
- THE TOWN OF PIERCEFIELD, IN THE COUNTY OF ST. LAWRENCE, THE 11 PROVISIONS OF THIS SECTION REQUIRING A PERSON TO BE A RESIDENT OF 12 13 POLITICAL SUBDIVISION OR MUNICIPAL CORPORATION OF THE STATE FOR WHICH HE OR SHE SHALL BE CHOSEN OR WITHIN WHICH HIS OR HER OFFICIAL FUNCTIONS ARE 14 TO BE EXERCISED, SHALL NOT PREVENT A PERSON FROM HOLDING THE 15 REOUIRED 16 OFFICE OF TOWN JUSTICE OF THE TOWN OF PIERCEFIELD, PROVIDED IN ST. LAWRENCE OR AN ADJOINING COUNTY WITHIN THE STATE 17 PERSON RESIDES
- 18 OF NEW YORK. PROVIDED, HOWEVER, THE PERSON PERFORMING THE FUNCTIONS OF 19 TOWN JUSTICE IN ANY OTHER TOWN SHALL BE A RESIDENT OF SUCH TOWN, UNLESS
- 20 OTHERWISE PROVIDED BY LAW.
