- AN ACT to amend the penal law, in relation to including employees of the office of children and family services on the list of public employees for which prevention of duties qualifies as assault in the second degree

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivisions 3 and 11 of section 120.05 of the penal law, 2 as amended by chapter 259 of the laws of 2013, are amended to read as 3 follows:

With intent to prevent a peace officer, a police officer, prosecu-5 tor as defined in subdivision thirty-one of section 1.20 of the criminal procedure law, registered nurse, licensed practical nurse, sanitation б 7 enforcement agent, New York city sanitation worker, a firefighter, including a firefighter acting as a paramedic or emergency medical tech-8 9 nician administering first aid in the course of performance of duty as such firefighter, an emergency medical service paramedic or emergency 10 11 medical service technician, or medical or related personnel in a hospital emergency department, a city marshal, a traffic enforcement 12 officer 13 traffic enforcement agent, OR EMPLOYEE OF A SECURE OR LIMITED SECURE or RESIDENTIAL FACILITY LICENSED, CERTIFIED OR OPERATED BY THE 14 OFFICE OF 15 CHILDREN AND FAMILY SERVICES, from performing a lawful duty, by means 16 including releasing or failing to control an animal under circumstances 17 evincing the actor's intent that the animal obstruct the lawful activity
