AN ACT to amend the penal law, in relation to assault on a prosecutor

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 3 of section 120.05 of the penal law, as 2 amended by chapter 377 of the laws of 2012, is amended to read as 3 follows:
