AN ACT to amend the general municipal law, in relation to the disclosure  
of records and registration information by libraries

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-  
BLY, DO ENACT AS FOLLOWS:

1     Section 1. The general municipal law is amended by adding a new  
2     section 79 to read as follows:  
3     S 79. DISCLOSURE OF RECORDS AND REGISTRATION INFORMATION BY LIBRARIES.  
4     1. ANY LIBRARY WHICH IS IN WHOLE OR IN PART SUPPORTED BY PUBLIC FUNDS,  
5     INCLUDING, BUT NOT LIMITED TO, PUBLIC, ACADEMIC, SCHOOL OR SPECIAL  
6     LIBRARIES, AND HAVING RECORDS INDICATING WHICH OF ITS DOCUMENTS OR OTHER  
7     MATERIALS, REGARDLESS OF FORMAT, HAVE BEEN LOANED TO OR USED BY AN IDEN-  
8     TIFIABLE INDIVIDUAL OR GROUP SHALL NOT DISCLOSE SUCH RECORDS TO ANY  
9     PERSON EXCEPT:  
10    A. PERSONS ACTING WITHIN THE SCOPE OF THEIR DUTIES IN THE ADMINIS-  
11    TRATION OF THE LIBRARY;  
12    B. PERSONS AUTHORIZED TO INSPECT SUCH RECORDS, IN WRITING, BY THE  
13    INDIVIDUAL OR GROUP; OR  
14    C. BY ORDER OF A COURT OF LAW.  
15    2. THE REQUIREMENTS OF THIS SECTION SHALL NOT PROHIBIT MIDDLE AND  
16    ELEMENTARY SCHOOL LIBRARIES FROM MAINTAINING A SYSTEM OF RECORDS THAT  
17    IDENTIFIES THE INDIVIDUAL OR GROUP TO WHOM LIBRARY MATERIALS HAVE BEEN  
18    LOANED EVEN IF SUCH SYSTEM PERMITS A DETERMINATION, INDEPENDENT OF ANY  
19    DISCLOSURE OF SUCH INFORMATION BY THE LIBRARY, THAT DOCUMENTS OR MATERI-  
20    ALS HAVE BEEN LOANED TO AN INDIVIDUAL OR GROUP.  
21    3. ALL REGISTRATION INFORMATION OF MINORS COLLECTED BY ANY LIBRARY  
22    WHICH IS SUPPORTED IN WHOLE OR IN PART BY PUBLIC FUNDS, INCLUDING, BUT  
23    NOT LIMITED TO, PUBLIC, ACADEMIC, SCHOOL OR SPECIAL LIBRARIES SHALL NOT  
24    BE DISCLOSED TO ANY PERSON EXCEPT:

1 A. PERSONS ACTING ONLY WITHIN THE LEGITIMATE SCOPE OF THEIR DUTIES IN  
2 THE ADMINISTRATION OF THE LIBRARY;

3 B. PERSONS AUTHORIZED TO INSPECT SUCH RECORDS, IN WRITING, BY THE  
4 INDIVIDUAL; OR

5 C. BY ORDER OF A COURT OF LAW.

6 4. FOR PURPOSES OF THIS SECTION, "REGISTRATION INFORMATION" INCLUDES  
7 ANY INFORMATION REQUIRED OF A MINOR IN ORDER TO BECOME ELIGIBLE TO  
8 BORROW BOOKS, UTILIZE LIBRARY SERVICES, AND OTHER MATERIALS.

9 5. ANY SUSPICIOUS REQUESTS FOR RECORDS OF MINORS THAT MAY BE INDIC-  
10 ATIVE OF CRIMINAL INTENT SHALL BE REPORTED IMMEDIATELY TO APPROPRIATE  
11 LAW ENFORCEMENT AUTHORITIES.

12 S 2. This act shall take effect immediately.
