AN ACT to amend the state law, the highway law and the administrative code of the city of New York in relation to renaming the Staten Island Expressway the "POW-MIA Memorial Highway"

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. Notwithstanding any other law to the contrary, the official  
2 name of all that portion of the state highway system located in Richmond  
3 county constituting route 440 from Outerbridge Crossing to route 278  
4 (West Shore Expressway) and route 278 from the Goethals bridge to the  
5 Verrazano-Narrows bridge (Staten Island Expressway) shall be the  
6 "POW-MIA Memorial Highway", as such highway is designated in section  
7 343-h of the highway law.  
8     S 2. Subdivisions 63 and 64 of section 121 of the state law, as added  
9 by chapter 16 of the laws of 2012, are amended to read as follows:  
10     63. Sixty-third district. In the county of Richmond, that part of the  
11 borough of Staten Island bounded by a line described as follows: Begin-  
12 ning at the point where the New York/New Jersey border intersects with a  
13 line extended northwesterly from Harbor Road, thence southeasterly along  
14 said line to Harbor Road, thence southerly along said road to Forest  
15 Avenue, thence easterly along said avenue to Summerfield Place, thence  
16 southerly along said place to Francesca Lane, thence southerly along  
17 said lane to Ludwig Lane, thence easterly along said lane to a line  
18 extended westerly from Baron Hirsch Cemetery Pathway, thence easterly  
19 along said line to said pathway, thence southeasterly along said pathway

31 avenue to 7th Avenue, thence southerly along said avenue to 79th street,  
32 thence westerly along said street to 3rd Avenue, thence northerly along  
33 said avenue to 78th Street, thence northwesterly along said street to  
34 Ridge Boulevard, thence southwesterly along said boulevard to 80th  
35 Street, thence northwesterly along said street to Colonial Road, thence

43 Kings County/New Jersey State line, the point and place of beginning;  
44 Furthermore, in the county of Richmond, that part of the borough of  
45 Staten Island bounded by a line described as follows: Beginning at a  
46 point where the Verrazano-Narrows Bridge meets the Kings/Richmond county  
47 line, thence southerly along the Richmond county line to a point where  
48 said line meets the New York/New Jersey State border, thence southwes-  
49 terly along said border, thence to a point intersecting a line extended  
50 southeasterly from Armstrong Avenue, thence northwesterly along said  
51 line to the intersection of said line and a line extended southerly from  
52 Point Street, thence northerly along said line to its intersection with  
53 a line extended southeasterly from the end of Robinson Avenue, thence  
54 northwesterly along said line to Thornycroft Avenue, thence northwester-

5 S 3. The paragraph relating to interstate route connection 512 of  
6 section 340-a of the highway law, as amended by chapter 453 of the laws  
7 of 2008, is amended to read as follows:

8 Interstate Route Connection 512. [Staten Island expressway] POW-MIA  
9 MEMORIAL HIGHWAY from Goethals bridge approach to Verrazano-Narrows  
10 bridge approach, Brooklyn-Queens expressway from Verrazano-Narrows  
11 bridge approach to Grand Central parkway, Grand Central parkway from  
12 Brooklyn-Queens expressway to Robert F. Kennedy bridge approach, Major  
13 Deegan expressway from Robert F. Kennedy bridge approach to the West-  
14 chester county line connecting with interstate route 502.

15 S 4. Section 343-a of the highway law, as added by chapter 110 of the  
16 laws of 1996, is amended to read as follows:

17 S 343-a. Portion of state highway system in the county of Richmond to  
18 be designated as "The Korean War Veterans Memorial Parkway". All that  
19 portion of the state highway system in the county of Richmond constitut-  
20 ing the Richmond Parkway from [Staten Island Expressway] POW-MIA MEMORI-  
21 AL HIGHWAY to Outerbridge Crossing Approach shall be designated and  
22 known as "The Korean War Veterans Memorial Parkway".

23 S 5. Section 349-f of the highway law, as amended by chapter 558 of  
24 the laws of 2010, is amended to read as follows:

25 S 349-f. New York city routes. The following existing or proposed main  
26 routes or thoroughfares, are designated herein, as aforesaid, viz.:

27 New England thruway from the Westchester county line to Bruckner  
28 expressway; Bruckner expressway from New England thruway to Robert F.  
29 Kennedy bridge approach; Hutchinson river parkway from the Westchester  
30 county line to the Bronx-Whitestone bridge approach; Bronx river parkway  
31 from the Westchester county line to Bruckner expressway; Henry Hudson  
32 parkway from the Westchester county line to Miller highway excepting the  
33 Henry Hudson bridge, provided that no portion of this route from West  
34 Seventy-second street to the Cross Bronx expressway shall be constructed  
35 or reconstructed so as to encroach in any way on or over any land mapped  
36 or used for park purposes except for such temporary encroachment of no  
37 more than ten feet in width from seventy-third street to seventy-sixth  
38 street as may be essential during and for the purpose of reconstruction  
39 or repair of the existing roadway following which there shall be full  
40 restoration of park land; Major Deegan expressway from the Robert F.  
41 Kennedy bridge to Central Park avenue at the Westchester county line  
42 together with a connection to Broadway and along Broadway to Manhattan  
43 college parkway; Cross Bronx expressway from George Washington bridge  
44 approach to Throgs Neck bridge; Throgs Neck expressway from Bruckner  
45 expressway to Throgs Neck bridge; Arthur V. Sheridan expressway from  
46 Cross-Bronx expressway to Bruckner expressway; Mosholu parkway from  
47 Henry Hudson parkway to Bronx river parkway; Bronx and Pelham parkway  
48 from Bronx river parkway to New England thruway; Boston road from Bronx  
49 and Pelham parkway to New England thruway; Miller highway from Henry  
50 Hudson parkway to the Hugh L. Carey tunnel; and from Hugh L. Carey  
51 tunnel to Brooklyn-Queens expressway; Franklin D. Roosevelt drive from  
52 the Hugh L. Carey tunnel to Robert F. Kennedy bridge approach; Harlem  
53 river drive from Robert F. Kennedy bridge approach to George Washington  
54 bridge approach; Belt parkway including Gowanus parkway to Third avenue  
55 and Sixtieth street, Leif Erikson drive to Knapp street, Shore parkway,  
56 Belt parkway, Southern parkway and Cross Island parkway from Hugh L.

1 Carey tunnel to Bronx-Whitestone bridge approach; Nassau expressway from  
2 Southern parkway to the Nassau county line; Brooklyn-Queens expressway  
3 from Gowanus expressway to Grand Central parkway; Prospect expressway  
4 from Gowanus expressway to Ocean parkway; Ocean parkway from Prospect  
5 expressway to Shore parkway; Interborough parkway from Grand Central  
6 Parkway to Belt parkway; Gowanus expressway from the Verrazano-Narrows  
7 bridge to Third avenue at Gowanus parkway; Third Avenue from Gowanus  
8 expressway to Hamilton avenue; Hamilton Avenue from Third Avenue to Hugh  
9 L. Carey tunnel; Queens boulevard from Queensborough bridge approach to  
10 Van Wyck expressway; Van Wyck expressway from Whitestone expressway,  
11 including a connection to Grand Central parkway, to John F. Kennedy  
12 international airport; Woodhaven boulevard from Queens boulevard to  
13 Cross Bay parkway bridge northerly approach; Cross Bay parkway from  
14 Cross Bay bridge southerly approach to Short Front parkway; Shore Front  
15 parkway from Cross Bay parkway generally along the shore line of the  
16 Atlantic ocean to the Nassau expressway at the Nassau county line;  
17 Queens-Midtown expressway from Queens-Midtown tunnel approach to Queens  
18 Boulevard; Horace Harding expressway from Queens Boulevard to the Nassau  
19 county line; a connection between Brooklyn-Queens expressway and North-  
20 ern boulevard in the vicinity of Grand Central parkway; Grand Central  
21 parkway from Robert F. Kennedy bridge approach to Nassau county line;  
22 Whitestone expressway from Bronx-Whitestone bridge approach to Van Wyck  
23 expressway and continuing to Grand Central parkway; Clearview expressway  
24 from Throgs Neck bridge to Nassau expressway; Richmond parkway from  
25 [Staten Island expressway] POW-MIA MEMORIAL HIGHWAY to Outerbridge  
26 crossing approach; [Staten Island expressway] POW-MIA MEMORIAL HIGHWAY  
27 from Goethals bridge to the Verrazano-Narrows bridge with a connection  
28 to Bayonne bridge; Willowbrook parkway from [Staten Island expressway]  
29 POW-MIA MEMORIAL HIGHWAY to Great Kills park; West Shore expressway from  
30 [Staten Island expressway] POW-MIA MEMORIAL HIGHWAY to Outerbridge  
31 crossing; Shore Front drive northerly from the terminus of West Shore  
32 expressway at [Staten Island expressway] POW-MIA MEMORIAL HIGHWAY,  
33 thence generally along the shore lines of Kill Van Kull, the Narrows,  
34 Lower New York bay and Raritan bay to the approach to Outerbridge cross-  
35 ing.

36 S 6. Paragraphs 1 and 35 of subdivision a of section 3-202 of the  
37 administrative code of the city of New York are amended to read as  
38 follows:

39 1. First District

40 That part of the Borough of Staten Island bounded by a line described  
41 as follows:

42 BEGINNING at a point in waters of Arthur Kill between border lines of  
43 New Jersey, and Richmond County, at Goethals Bridge, proceeding south-  
44 east, to Railroad cut, then proceeding east, to Gulf Avenue, to [Staten  
45 Island Expressway] POW-MIA MEMORIAL HIGHWAY, to Bengal Avenue, to Fahy  
46 Avenue, to Arlene Street, to Lander Avenue, to Richmond Avenue, to  
47 Victory Boulevard, to Willowbrook Road, to Watchogue Road, to Victory

4 That part of the Borough of Staten Island bounded by a line described

4       S 8. The commissioner of transportation shall provide for the instal-  
5 lation and maintenance of adequate signing of the state highway system
