AN ACT to amend the environmental conservation law, in relation to authorizing hunting in the county of Wayne; and providing for the repeal of such provisions upon expiration thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Paragraph a of subdivision 2 of section 11-0907 of the 2 environmental conservation law is amended by adding a new item (k) to 3 read as follows:

(K) THE COUNTY OF DEER, THE FIRST PISTOL, SHOTGUN,
WAYNE SATURDAY AFTER NOVEMBER MUZZLE LOADING
15 THROUGH FIRST SUNDAY FIREARM, RIFLE
AFTER DECEMBER 7 OR LONG BOW ONLY

- 8 S 2. Item (f) of paragraph a of subdivision 2 of section 11-0907 of 9 the environmental conservation law, as amended by section 1 of chapter 10 323 of the laws of 2011, is amended to read as follows:
- (f) Southern tier, 11 Deer, first Pistol, shotgun, 12 central and Western Monday after muzzle loading November 15 13 region, except those firearm or 14 through first long bow only counties or portions 15 thereof listed in Tuesday after 16 item (i) [or], (j), December 7

S 4. This act shall take effect immediately, provided that:

- a. the amendments to paragraph a of subdivision 2 of section 11-0907 of the environmental conservation law made by section one of this act shall be subject to the expiration and reversion of such paragraph pursuant to section 13 of chapter 600 of the laws of 1993, as amended;
- b. the amendments to item (f) of paragraph a of subdivision 2 of section 11-0907 of the environmental conservation law made by section two of this act shall be subject to the expiration and reversion of such item and shall expire and be deemed repealed therewith, when upon such date the provision of section three of this act shall take effect;
- c. the amendments to item (f) of paragraph a of subdivision 2 of section 11-0907 of the environmental conservation law made by section three of this act shall be subject to the expiration and reversion of such paragraph and shall expire and be deemed repealed therewith; and
- d. nothing contained in this act shall be construed so as to extend the provisions of this act beyond October 1, 2015, when upon such date this act shall expire and the provisions contained herein shall be deemed repealed.
