Introduced by Sen. CARLUCCI -- read twice and ordered printed, and when printed to be committed to the Committee on Mental Health and Developmental Disabilities

AN ACT to amend the mental hygiene law, in relation to creating a bill of rights for family and guardians of people with developmental disabilities that reside in residences funded, licensed and operated by the office for people with developmental disabilities

PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

- Section 1. The mental hygiene law is amended by adding a new 13.04 to read as follows:
- S 13.04 FAMILY BILL OF RIGHTS.

- PRINCIPLES ENUNCIATED IN SUBDIVISION (C) OF THIS SECTION ARE (A) DECLARED TO BE THE PUBLIC POLICY OF THE STATE AND A COPY OF SUCH MENT OF RIGHTS SHALL BE POSTED CONSPICUOUSLY IN A PUBLIC PLACE IN EACH RESIDENCE FUNDED, LICENSED AND OPERATED BY THE OFFICE. FOR PURPOSES OF THIS SECTION, "QUALIFIED FAMILY MEMBER" MEANS A PARENT, SPOUSE, SIBLING, GRANDPARENT, AUNT, UNCLE OR AN ADULT CHILD OF THE RESIDENT.
- 10 COMMISSIONER SHALL MAKE AVAILABLE TO EVERY RESIDENCE FUNDED, LICENSED AND OPERATED BY THE OFFICE, ON THE OFFICE'S WEBSITE A COPY OF 11 STATEMENT OF RIGHTS PROVIDED IN SUBDIVISION (C) OF THIS SECTION IN 12 THE TOP SIX LANGUAGES OTHER THAN ENGLISH SPOKEN IN THE 13 STATE 14 LATEST AVAILABLE DATA FROM THE U.S. BUREAU OF CENSUS, AND SHALL 15 ADOPT ANY RULES AND REGULATIONS NECESSARY TO ENSURE THAT SUCH OUALIFIED 16 FAMILY MEMBERS AND GUARDIANS ARE TREATED ΙN ACCORDANCE WITH PROVISIONS OF SUCH STATEMENT.

  - (C) THE STATEMENT OF RIGHTS SHALL CONSIST OF THE FOLLOWING:
- 19 "FAMILY BILL OF RIGHTS"
- 20 QUALIFIED FAMILY MEMBERS AND GUARDIANS SHALL HAVE THE FOLLOWING RIGHTS
- IN REGARDS TO A RESIDENT WHO RESIDES IN A RESIDENCE FUNDED, OPERATED OR 21
- 22 LICENSED BY THE OFFICE. THESE RIGHTS SHALL INCLUDE:

YOU HAVE THE RIGHT TO HAVE ACCESS TO A RESIDENCE'S FIRE SAFETY PLAN AND ANY INFORMATION REGARDING A RESIDENCE'S PASSAGE OR FAILURE OF ANY FIRE SAFETY DRILLS CONDUCTED BY THE RESIDENCE AND THE OFFICE.

YOU HAVE THE RIGHT TO IMMEDIATE NOTIFICATION OF ANY EVENT THAT WOULD IMPACT THE HEALTH AND SAFETY OF THE INDIVIDUAL.

YOU HAVE THE RIGHT TO HAVE ACCESS TO INFORMATION REGARDING THE HEALTH AND SAFETY OF THE INDIVIDUAL.

YOU HAVE THE RIGHT TO HAVE ACCESS TO A RESIDENCE'S FOOD MENUS.

9 YOU HAVE THE RIGHT FOR A QUALIFIED FAMILY MEMBER OR GUARDIAN TO BE 10 ABLE TO HAVE UNANNOUNCED VISITS.

YOU HAVE THE RIGHT TO HAVE INPUT IN ANY DECISION MADE BY THE OFFICE OR LOCAL GOVERNMENTAL UNIT REGARDING THE APPROPRIATE PLACEMENT OF A PERSON WITH DEVELOPMENTAL DISABILITIES WITHIN A RESIDENCE OR THE DECISION TO TRANSFER A PERSON WITH DEVELOPMENTAL DISABILITIES FROM ONE RESIDENCE TO ANOTHER.

YOU HAVE THE RIGHT TO FINANCIAL TRANSPARENCY INCLUDING ACCESS TO BUDGETARY INFORMATION OF THE RESIDENCE INCLUDING INDIVIDUAL EXPENSES.

YOU HAVE THE RIGHT TO ACCESS ALL JUSTICE CENTER REPORTS OF INVESTI-19 GATIONS OF ALLEGATIONS OF ABUSE AND ANY REPORTS REGARDING FINAL DETERMI-20 NATIONS REGARDING ANY DEATHS OR ABUSE IN RESIDENTIAL FACILITIES.

YOU HAVE THE RIGHT TO BE INFORMED REGARDING ANY STAFFING CHANGES.

FOR PURPOSES OF MEDICAID WAIVERS OBTAINED BY THE STATE:

YOU HAVE THE RIGHT TO CHOOSE A CARE COORDINATOR

24 YOU HAVE THE RIGHT TO HAVE ACCESS TO ALL DOCUMENTS AND INFORMATION 25 REGARDING CARE AND PROGRAMS

YOU HAVE THE RIGHT TO INDEPENDENT ADVOCATES

YOU HAVE THE RIGHT TO MANDATED PROCEDURES IF QUALIFIED FAMILY MEMBERS OR GUARDIANS NEED TO CHALLENGE A DECISION

ALL THE ABOVE ARE YOUR RIGHTS. IF THE RESIDENTIAL FACILITY DOES NOT HONOR THESE RIGHTS YOU CAN SEEK HELP BY CONTACTING THE NEW YORK STATE DEPARTMENT OF HEALTH OR BY CONTACTING THE RESIDENTIAL FACILITY.

- (D) THE COMMISSIONER SHALL ESTABLISH A PUBLIC EDUCATION PROGRAM TO DISSEMINATE INFORMATION REGARDING IMPLEMENTATION OF THIS SECTION. SUCH INFORMATION SHALL INCLUDE, BUT NOT BE LIMITED TO, PUBLICATION OF THE FAMILY BILL OF RIGHTS AS SPECIFIED IN SUBDIVISION (C) OF THIS SECTION; PUBLICATION OF THE RIGHTS OF QUALIFIED FAMILY MEMBERS AND GUARDIANS OF A RESIDENT WHO RESIDES IN A RESIDENCE FUNDED, OPERATED OR LICENSED BY THE OFFICE; AND PUBLICATION OF CERTAIN PROVISIONS RELATING TO MEDICAID WAIVERS OBTAINED BY THE STATE.
- 40 S 2. This act shall take effect immediately.
