AN ACT to amend the public health law and the insurance law, in relation to the right to external review of services provided pursuant to the fully integrated dual advantage program

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 4910 of the public health law is amended by adding 2 a new subdivision 5 to read as follows:

3 SUBJECT TO APPROVAL BY THE CENTERS FOR MEDICARE AND MEDICAID 5. SERVICES, THE PROVISIONS OF THIS TITLE ARE APPLICABLE TO ADVERSE 4 DETER-5 MINATIONS MADE WITH RESPECT TO HEALTH CARE SERVICES PROVIDED TO INDIVID-6 INTEGRATED DUAL ADVANTAGE (FIDA) PROGRAM UALS ENROLLED IN THE FULLY PURSUANT SUBDIVISION 7 ΤO TWENTY-SEVEN OF THREE ESTABLISHED SECTION 8 HUNDRED SIXTY-FOUR-J OF THE SOCIAL SERVICES LAW, AS ADDED BY SECTION 9 SEVENTY-TWO OF PART A OF CHAPTER FIFTY-SIX OF THE LAWS OF TWO THOUSAND 10 THIRTEEN.

11 S 2. Section 4910 of the insurance law is amended by adding a new 12 subsection (e) to read as follows:

13 (E) SUBJECT TO APPROVAL BY THE CENTERS FOR MEDICARE AND MEDICAID THE PROVISIONS OF THIS TITLE ARE APPLICABLE TO ADVERSE DETER-14 SERVICES. MINATIONS MADE WITH RESPECT TO HEALTH CARE SERVICES PROVIDED TO INDIVID-15 16 UALS ENROLLED IN THE FULLY INTEGRATED DUAL ADVANTAGE (FIDA) PROGRAM PURSUANT TO SUBDIVISION TWENTY-SEVEN OF SECTION 17 ESTABLISHED THREE 18 HUNDRED SIXTY-FOUR-J OF THE SOCIAL SERVICES LAW, AS ADDED ΒY SECTION SEVENTY-TWO OF PART A OF CHAPTER FIFTY-SIX OF THE LAWS OF TWO THOUSAND 19 20 THIRTEEN.

21 S 3. This act shall take effect immediately.
