AN ACT to amend the social services law, in relation to adult protective services

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Section 473 of the social services law is amended by adding a new subdivision 8 to read as follows:

3 THE COMMISSIONER SHALL PREPARE FOR INCLUSION IN THE ANNUAL 8. (A) 4 REPORT REQUIRED BY SUBDIVISION (D) OF SECTION SEVENTEEN OF THIS CHAPTER 5 FILED WITH THE GOVERNOR AND THE LEGISLATURE PRIOR TO DECEMBER TO BE 6 FIFTEENTH OF EACH YEAR, A REPORT OF THE ACTIVITIES AND SERVICES PROVIDED BY SOCIAL SERVICES OFFICIALS IN SOCIAL SERVICES DISTRICTS WITHIN 7 THE 8 REQUIRED BY THIS SECTION. THE REPORT SHALL INCLUDE A LIST OF STATE AS 9 SOCIAL SERVICES DISTRICTS WITHIN THE STATE TOGETHER WITH CONTACT INFOR-MATION FOR EACH. FOR EACH SOCIAL SERVICES DISTRICT WITHIN THE STATE, 10 SUCH REPORT SHALL ALSO INCLUDE AN INDICATION OF THE NUMBER OF ADULTS 11 HAVE BEEN PROVIDED ADULT PROTECTIVE SERVICES IN THAT REPORTING 12 THAT PERIOD, A SUMMARY OF THE TYPES OF ADULT PROTECTIVE 13 SERVICES PROVIDED, 14 AND THE STATUS OF ANY DISTRICT-WIDE PLAN FOR THE PROVISION OF ADULT 15 PROTECTIVE SERVICES.

(B) FOR THE PURPOSE OF IMPLEMENTING IMPROVED METHODS FOR THE 16 DELIVERY 17 OF PROTECTIVE SERVICES FOR ADULTS, THE DEPARTMENT SHALL DEVELOP BEST PRACTICES, POLICIES, PROTOCOLS AND PROCEDURES WITH RESPECT 18 ТО THE 19 PROVISION OF THE SERVICES REQUIRED BY THIS SECTION. IN DEVELOPING SUCH 20 BEST PRACTICES, POLICIES, PROTOCOLS AND PROCEDURES, THE DEPARTMENT MAY CONSULT WITH SOCIAL SERVICES DISTRICTS, SOCIAL SERVICES OFFICIALS, AND 21 ORGANIZATIONS THAT ARE STATE OR FEDERALLY RECOGNIZED AUTHORITIES ON 22 23 MATTERS PERTAINING TO ADULT PROTECTIVE SERVICES. SUCH BEST PRACTICES, 24 POLICIES, PROTOCOLS AND PROCEDURES SHALL BE DEVELOPED BY OR BEFORE JANU-ARY FIRST, TWO THOUSAND FIFTEEN, AND THE COMMISSIONER SHALL POST THE 25
