AN ACT to amend the mental hygiene law, in relation to the distribution of educational materials regarding the misuse of and addiction to prescription drugs

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. Section 19.09 of the mental hygiene law is amended by 1 adding a new subdivision (i) to read as follows:

3 (I) (1) THE COMMISSIONER, IN CONSULTATION WITH THE COMMISSIONER OF 4 HEALTH, SHALL CREATE OR UTILIZE EXISTING EDUCATIONAL MATERIALS WHICH 5 SHALL INCLUDE INFORMATION REGARDING THE DANGERS OF MISUSE AND THE POTEN-TIAL FOR ADDICTION TO PRESCRIPTION DRUGS, TREATMENT RESOURCES AVAILABLE, 6 7 AND THE PROPER WAY TO DISPOSE OF UNUSED PRESCRIPTION DRUGS. SUCH MATE-RIALS SHALL BE MADE AVAILABLE TO PHARMACISTS AND MAY BE DISTRIBUTED WITH 8 9 PRESCRIBED DRUG THAT IS A CONTROLLED SUBSTANCE BY A PHARMACIST ANY 10 LICENSED BY THE STATE TO DISPENSE PRESCRIPTION DRUGS ТО THE PUBLIC PURSUANT TO SECTION SIXTY-EIGHT HUNDRED FIVE OF THE EDUCATION LAW. THE 11 INFORMATION CONTAINED IN SUCH MATERIALS SHALL ALSO BE 12 POSTED ON THE 13 WEBSITE OF THE OFFICE AND THE DEPARTMENT OF HEALTH. SUCH MATERIALS SHALL BE PROVIDED IN LANGUAGES OTHER THAN ENGLISH AS DEEMED APPROPRIATE BY THE 14 15 COMMISSIONERS.

(2) UTILIZING DATA THAT IS AVAILABLE TO THE OFFICE, INCLUDING, BUT NOT 16 LIMITED TO, INFORMATION OBTAINED PURSUANT TO SUBDIVISION FOUR OF SECTION 17 18 THIRTY-THREE HUNDRED NINE-A OF THE PUBLIC HEALTH LAW, THE COMMISSIONER 19 SHALL IDENTIFY THE COUNTIES IN NEW YORK STATE WHERE PRESCRIPTION OPIOID 20 ABUSE IS MOST PREVALENT. PHARMACISTS LICENSED BY THE STATE TO DISPENSE PRESCRIPTION DRUGS MAY BE NOTIFIED AT THE DISCRETION OF THE COMMISSIONER 21 IN COLLABORATION WITH THE DEPARTMENT OF HEALTH, ABOUT THE PREVALENCE 22 OF THE COUNTY IN WHICH SUCH PHARMACISTS ARE LOCATED AND 23 OPIOID ABUSE IN 24 ENCOURAGE THE FACILITIES WHERE PRESCRIPTION DRUGS ARE ТО DISPENSED 25 DISTRIBUTE MATERIALS CREATED OR UTILIZED PURSUANT TO PARAGRAPH ONE OF 26 THIS SUBDIVISION.

S 2. This act shall take effect on the sixtieth day after it shall 27 28 have become a law.
