AN ACT to amend the military law and the public health law, in relation to enacting the "veterans long-term care access act"

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. This act shall be known and may be cited as the "veterans
 long-term care access act".
 S 2. The military law is amended by adding a new section 235-b to read

 S 235-B. MEDICAID ELIGIBILITY FOR VETERANS IN STATE VETERANS HOMES.
 NOTWITHSTANDING ANY LAW, RULE OR REGULATION TO THE CONTRARY, NO HONOR-

7 ABLY DISCHARGED MILITARY VETERAN, THEIR SPOUSE OR WIDOW, OR THE GOLD 8 STAR PARENT OF SUCH VETERAN SHALL BE REQUIRED TO ENROLL IN A MEDICAID 9 MANAGED CARE PLAN OR A MEDICAID LONG TERM CARE PLAN IF HE OR SHE IS ACCEPTED FOR ADMISSION INTO A STATE VETERANS HOME OR 10 ENROLLED IN A MEDICAL MODEL ADULT DAY HEALTH CARE PROGRAM AT A STATE VETERANS HOME. 11 SUCH HONORABLY DISCHARGED VETERAN, THEIR SPOUSE OR WIDOW, OR GOLD 12 STAR 13 PARENT SHALL NOT BE SUBJECT TO THE REQUIREMENTS OF ANY PLAN OF TRANSI-TION OF NURSING HOME POPULATIONS INTO ANY MANAGED CARE PROGRAMS OTHER-14 WISE ADOPTED AND APPROVED BY THE DEPARTMENT. 15

S 2636. REIMBURSEMENT FOR SERVICES RENDERED.
