AN ACT to amend the vehicle and traffic law in relation to creating the "4-H member" distinctive license plate; and to amend the state finance law, in relation to establishing the 4-H foundation fund

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The vehicle and traffic law is amended by adding a new
2 section 404-x to read as follows:
3 S 404-X. DISTINCTIVE 4-H MEMBER LICENSE PLATES. 1. ANY PERSON RESIDING
4 IN THIS STATE SHALL, UPON REQUEST, BE ISSUED A DISTINCTIVE "4-H MEMBER"
5 LICENSE PLATE. APPLICATION FOR SUCH LICENSE PLATE SHALL BE FILED WITH
6 THE COMMISSIONER IN SUCH FORM AND DETAIL AS THE COMMISSIONER SHALL
7 PRESCRIBE.
8 2. A DISTINCTIVE PLATE ISSUED PURSUANT TO THIS SECTION SHALL BE ISSUED
9 IN THE SAME MANNER AS OTHER NUMBER PLATES UPON THE PAYMENT OF THE REGU-
10 LAR REGISTRATION FEE PRESCRIBED BY SECTION FOUR HUNDRED ONE OF THIS
11 ARTICLE; PROVIDED, HOWEVER, THAT AN ADDITIONAL ANNUAL SERVICE CHARGE OF
12 TWENTY-FIVE DOLLARS SHALL BE CHARGED FOR SUCH PLATES. SUCH ANNUAL
13 SERVICE CHARGE SHALL BE DEPOSITED PURSUANT TO THE PROVISIONS OF SECTION
14 FOUR HUNDRED FOUR-00 OF THIS ARTICLE, TO THE CREDIT OF THE DEPARTMENT OF
15 MOTOR VEHICLES DISTINCTIVE PLATE DEVELOPMENT FUND ESTABLISHED BY SECTION
16 NINETY-FIVE-G OF THE STATE FINANCE LAW, AND SHALL BE USED FOR THE
17 PRODUCTION, DESIGN, ADVERTISING AND MARKETING OF DISTINCTIVE LICENSE
18 PLATES PURSUANT TO SUCH SECTION NINETY-FIVE-G; PROVIDED, HOWEVER, THAT
19 ANNUAL SERVICE CHARGES COLLECTED IN EXCESS OF SIX THOUSAND DOLLARS SHALL
20 BE DEPOSITED TO THE CREDIT OF THE NEW YORK 4-H FOUNDATION AND SHALL BE
21 USED FOR FURTHERANCE OF THE 4-H PROGRAM, PURSUANT TO SECTION NINETY-SIX
22 OF THE STATE FINANCE LAW.
23 S 2. The state finance law is amended by adding a new section 96 to
24 read as follows:
25 S 96. THE 4-H FOUNDATION FUND. 1. THERE IS HEREBY ESTABLISHED, IN THE
26 JOINT CUSTODY OF THE COMMISSIONER OF TAXATION AND FINANCE AND THE COMP-
27 TROLLER, A SPECIAL FUND TO BE KNOWN AS THE 4-H FOUNDATION FUND.

1 2. SUCH FUND SHALL CONSIST OF ALL REVENUES RECEIVED PURSUANT TO THE
2 PROVISIONS OF SECTION FOUR HUNDRED FOUR-X OF THE VEHICLE AND TRAFFIC LAW
3 AND ALL OTHER MONEYS APPROPRIATED, CREDITED, OR TRANSFERRED THERETO FROM
4 ANY OTHER FUND OR SOURCE PURSUANT TO LAW. NOTHING CONTAINED IN THIS
5 SECTION SHALL PREVENT THE STATE FROM RECEIVING GRANTS, GIFTS, OR
6 REQUESTS FOR THE PURPOSES OF THE FUND, AS DEFINED IN THIS SECTION, AND
7 DEPOSITING THEM INTO THE FUND ACCORDING TO LAW.

8 3. MONIES OF THE FUND SHALL BE EXPENDED ONLY FOR THE BENEFIT AND
9 PROGRAMS OF THE 4-H FOUNDATION.

10 4. MONIES SHALL BE PAYABLE FROM THE FUND ON THE AUDIT AND WARRANT OF
11 THE COMPTROLLER ON VOUCHERS APPROVED AND CERTIFIED BY THE COMMISSIONER
12 OF AGRICULTURE AND MARKETS.

13 5. TO THE EXTENT POSSIBLE, THE COMMISSIONER OF AGRICULTURE AND MARKETS
14 SHALL ENSURE THAT ALL MONIES RECEIVED DURING A FISCAL YEAR ARE EXPENDED
15 PRIOR TO THE END OF THAT FISCAL YEAR.

16 S 3. This act shall take effect on the one hundred eightieth day after
17 it shall have become a law.
