AN ACT to amend the education law, in relation to consolidation with city school districts

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. Subdivision 1 of section 1524 of the education law, as  
2 amended by chapter 461 of the laws of 1996, is amended to read as  
3 follows:  
4     1. Notwithstanding the provisions of this chapter or any other gener-  
5 al, special, or local law to the contrary, whenever the qualified voters  
6 of a school district which is contiguous to the city school district OR  
7 IN CLOSE PROXIMITY TO THE CITY SCHOOL DISTRICT of a city with less than  
8 one hundred twenty-five thousand inhabitants, according to the latest  
9 federal census, by a majority vote taken at an annual or special meeting  
10 of such district shall adopt a proposition to consolidate such school  
11 district with such city school district, and the board of education of  
12 such city school district shall by resolution duly adopted consent ther-  
13 eto, the commissioner [of education] may by order consolidate such  
14 school district with such city school district; provided, however, that  
15 where several school districts are contiguous to each other and at least  
16 one of such school districts is contiguous to such city school district  
17 OR IN CLOSE PROXIMITY TO SUCH CITY SCHOOL DISTRICT, such vote may be  
18 taken in each of such school districts at the same time, and if the  
19 proposition to consolidate is adopted by a majority vote in each such  
20 district, including any votes cast by absentee ballot as provided under  
21 section two thousand eighteen-a or two thousand eighteen-b of this chap-  
22 ter, whichever shall apply, and upon the consent of the city school  
23 district board of education, the commissioner [of education] may include  
24 each such district in one order of consolidation; provided, further,  
25 however, that if the proposition to consolidate is not adopted by a  
26 majority vote in each such district, but is so adopted in one or more of  
27 such districts, upon the consent of the city school district board of  
28 education, the commissioner may include in one order of consolidation

1 only such district or districts as, either singly or as a group, are  
2 contiguous to such city school district OR IN CLOSE PROXIMITY TO SUCH  
3 CITY SCHOOL DISTRICT. Such order shall specify a date on which the same  
4 shall take effect, and shall have the same effect as an order made by a  
5 district superintendent dissolving two or more common school districts  
6 and forming a new district therefrom, or dissolving one or more common  
7 school districts and uniting the territory thereof to a union free  
8 school district under the provisions of article thirty-one of this chap-  
9 ter. A copy of such order shall be filed with the clerk of each school  
10 district affected thereby.  
11 S 2. This act shall take effect immediately.
