AN ACT to amend the mental hygiene law, in relation to the prescription of antidepressant and antianxiety medications which have an increased risk of suicidal behavior

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- Section 1. The mental hygiene law is amended by adding a new section 7.45 to read as follows:
  - S 7.45 ANTIDEPRESSANT AND ANTIANXIETY MEDICATIONS; SUICIDE RISK.

- (A) WHEN A PATIENT RECEIVES A PRESCRIPTION FOR AN ANTIDEPRESSANT OR ANTIANXIETY MEDICATION IN AN OUTPATIENT SETTING, AND THE MEDICATION HAS AN INCREASED RISK OF SUICIDALITY, THE OFFICE SHALL IDENTIFY SUCH MEDICATIONS AND SHALL REQUIRE PHARMACISTS IN THE COURSE OF CONSULTATION, UPON THE FIRST TIME DISPENSING OF THE MEDICATION TO THE PATIENT, TO PROVIDE THE FOLLOWING:
- 10 (1) THE TOLL-FREE SUICIDE PREVENTION LIFELINE TELEPHONE NUMBER ESTAB-11 LISHED BY THE OFFICE;
  - (2) THE SUICIDE PREVENTION LIFELINE WEBSITE INTERNET ADDRESS ESTAB-LISHED BY THE OFFICE; AND
  - (3) A PAMPHLET PUBLISHED BY THE OFFICE SETTING FORTH ALL RELEVANT INFORMATION REGARDING THE INCREASED RISK OF SUICIDE AND SUICIDAL SIDE EFFECTS ASSOCIATED WITH THE MEDICATION, INCLUDING, BUT NOT LIMITED TO, INFORMATION SETTING FORTH THE WARNING SIGNS ASSOCIATED WITH SUCH SUICIDAL BEHAVIOR AND ANY OTHER INFORMATION THE OFFICE DEEMS RELEVANT.
  - (B) ANY CONSULTATION REQUIRED BY SUBDIVISION (A) OF THIS SECTION WITH A PERSON UNDER SEVENTEEN YEARS OF AGE SHALL REQUIRE THAT A PARENT OR LEGAL GUARDIAN OF SUCH PERSON BE IN ATTENDANCE DURING SUCH CONSULTATION.
- LEGAL GUARDIAN OF SUCH PERSON BE IN ATTENDANCE DURING SUCH CONSULTATION.

  (C) NO MEDICATION DESCRIBED IN SUBDIVISION (A) OF THIS SECTION SHALL

  BE DISPENSED, DISPERSED OR OTHERWISE GIVEN TO A PERSON UNDER SEVENTEEN

  YEARS OF AGE UNLESS A PARENT OR LEGAL GUARDIAN OF SUCH PERSON IS IN

  ATTENDANCE.

(D) THE OFFICE IS AUTHORIZED AND DIRECTED TO PROMULGATE ANY RULES AND REGULATIONS AND PREPARE PAMPHLETS NECESSARY TO IMPLEMENT THE PROVISIONS OF THIS SECTION.

S 2. This act shall take effect on the ninetieth day after it shall have become a law; provided, however, that effective immediately, the addition, amendment and/or repeal of any rule or regulation necessary for the implementation of this act on its effective date is authorized to be made and completed on or before such date.
