AN ACT to amend the real property tax law and the real property law, in relation to the taxation of property owned by a cooperative corporation

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 1 of section 581 of the real property tax law 2 is amended by adding a new paragraph (d) to read as follows:

3 (D) THE PROVISIONS OF PARAGRAPH (A) OF THIS SUBDIVISION SHALL NOT 4 APPLY TO REAL PROPERTY OWNED OR LEASED BY A COOPERATIVE CORPORATION OR 5 ON A CONDOMINIUM BASIS IN A MUNICIPAL CORPORATION, OTHER THAN A SPECIAL б ASSESSING UNIT, WHICH HAS ADOPTED, PRIOR TO THE TAXABLE STATUS DATE OF 7 THE ASSESSMENT ROLL UPON WHICH ITS TAXES WILL BE LEVIED, A LOCAL LAW OR, FOR A SCHOOL DISTRICT, A RESOLUTION PROVIDING THAT THE PROVISIONS 8 OF 9 PARAGRAPH (A) OF THIS SUBDIVISION SHALL NOT APPLY TO SUCH REAL PROPERTY WITHIN THAT MUNICIPAL CORPORATION; PROVIDED, HOWEVER, THE PROVISIONS 10 OF SHALL NOT APPLY TO REAL PROPERTY OWNED OR LEASED BY A 11 THIS PARAGRAPH 12 COOPERATIVE CORPORATION OR ON A CONDOMINIUM BASIS THAT HAD BEEN PREVI-13 OUSLY SUBJECT TO THE PROVISIONS OF PARAGRAPH (A) OF THIS SUBDIVISION 14 PRIOR TO JANUARY FIRST, TWO THOUSAND FIFTEEN.

15 S 2. Subdivision 1 of section 339-y of the real property law is 16 amended by adding a new paragraph (g) to read as follows:

PARAGRAPH (B) OF THIS SUBDIVISION SHALL NOT 17 THE PROVISIONS OF (G) APPLY TO REAL PROPERTY OWNED OR LEASED BY A COOPERATIVE CORPORATION OR 18 ON A CONDOMINIUM BASIS IN A MUNICIPAL CORPORATION OTHER THAN A SPECIAL 19 20 ASSESSING UNIT, WHICH HAS ADOPTED, PRIOR TO THE TAXABLE STATUS DATE OF 21 THE ASSESSMENT ROLL UPON WHICH ITS TAXES WILL BE LEVIED, A LOCAL LAW OR, SCHOOL DISTRICT, A RESOLUTION PROVIDING THAT THE PROVISIONS OF 22 FOR A PARAGRAPH (B) OF THIS SUBDIVISION SHALL NOT APPLY TO SUCH REAL 23 PROPERTY
