- ACT to amend the education law, in relation to directing the commis-AN sioner of education to conduct an audit and report on statewide compliance with state instructional regulations for arts education

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. The education law is amended by adding a new section 816 to 1 read as follows: 2

3 S 816. ARTS INSTRUCTION COMPLIANCE. 1. THE COMMISSIONER SHALL BE4 AUTHORIZED AND REQUIRED TO COLLECT THE NECESSARY DATA AND INFORMATION TO 5 ASSESS COMPLIANCE WITH STATE EDUCATION REGULATIONS FOR ARTS INSTRUCTION б AT ALL SCHOOLS THROUGHOUT THE STATE ONCE EVERY FIVE YEARS. THE BOARD OF EDUCATION OR TRUSTEES OF ALL SCHOOL DISTRICTS SHALL COMPLY WITH REQUESTS 7 8 BY THE DEPARTMENT FOR SUCH INFORMATION AS IS DEEMED RELEVANT ΒY THE 9 DEPARTMENT.

10 2. THE INITIAL ASSESSMENT REQUIRED BY THE PROVISIONS OF THIS SECTION 11 SHALL BE CONDUCTED AND REPORTED TO THE LEGISLATURE AND THE PUBLIC BY JUNE, TWO THOUSAND FOURTEEN FOR THE TWO THOUSAND THIRTEEN--TWO THOUSAND 12 13 FOURTEEN SCHOOL YEAR AND EVERY FIVE YEARS THEREAFTER.

14 3. ONCE A DISTRICT HAS BEEN FOUND TO BE COMPLIANT WITH THE STATE EDUCATION REGULATIONS FOR ARTS INSTRUCTION, THE COMMISSIONER SHALL NOT 15 BE REOUIRED TO ASSESS OR EVALUATE THAT DISTRICT'S LEVEL OF COMPLIANCE AS 16 PROVIDED IN SUBDIVISION ONE OF THIS SECTION OR TO INCLUDE 17 INFORMATION DISTRICT'S COMPLIANCE WITH STATE EDUCATION REGULATIONS 18 THE CONCERNING 19 FOR ARTS INSTRUCTION IN THE REPORT TO THE LEGISLATURE AND THE PUBLIC AS 20 PROVIDED IN SUBDIVISION TWO OF THIS SECTION. 21

S 2. This act shall take effect immediately.
