AN ACT to amend the vehicle and traffic law and the state finance law, in relation to creating the "September eleventh, two thousand one remembrance" distinctive license plate program

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. The vehicle and traffic law is amended by adding section 404-x to read as follows:

- 404-X. DISTINCTIVE "SEPTEMBER ELEVENTH, TWO THOUSAND ONE REMEM-BRANCE" LICENSE PLATES. 1. ANY PERSON RESIDING IN THIS STATE SHALL, UPON REQUEST, BE ISSUED A DISTINCTIVE "SEPTEMBER ELEVENTH, TWO REMEMBRANCE" LICENSE PLATE. APPLICATION FOR SUCH LICENSE PLATE SHALL BE FILED WITH THE COMMISSIONER IN SUCH FORM AND DETAIL AS THE COMMISSIONER SHALL PRESCRIBE.
- 2. A DISTINCTIVE PLATE ISSUED PURSUANT TO THIS SECTION SHALL BE ISSUED THE SAME MANNER AS OTHER NUMBER PLATES UPON THE PAYMENT OF THE REGU-LAR REGISTRATION FEE PRESCRIBED BY SECTION FOUR HUNDRED ONE OF THIS PROVIDED, HOWEVER, THAT AN ADDITIONAL ANNUAL SERVICE CHARGE OF TWENTY-FIVE DOLLARS SHALL BE CHARGED 13 FOR SUCH PLATES. SUCH SERVICE CHARGE SHALL BE DEPOSITED PURSUANT TO THE PROVISIONS OF SECTION 14 FOUR HUNDRED FOUR-OO OF THIS ARTICLE, TO THE CREDIT OF THE DEPARTMENT OF 15 MOTOR VEHICLES DISTINCTIVE PLATE DEVELOPMENT FUND ESTABLISHED BY SECTION NINETY-FIVE-G OF THE STATE FINANCE LAW, AND SHALL BE 17 USED FOR PRODUCTION, DESIGN, ADVERTISING AND MARKETING OF DISTINCTIVE LICENSE 18

PLATES PURSUANT TO SUCH SECTION NINETY-FIVE-G; PROVIDED, HOWEVER, THAT
ANNUAL SERVICE CHARGES COLLECTED IN EXCESS OF SIX THOUSAND DOLLARS SHALL
BE DEPOSITED TO THE CREDIT OF "THE SEPTEMBER ELEVENTH, TWO THOUSAND ONE
SCHOLARSHIP FUND" ESTABLISHED PURSUANT TO SECTION NINETY-SIX-A OF THE

9 S 2. The state finance law is amended by adding a new section 96-a to 10 read as follows:

- S 96-A. THE SEPTEMBER ELEVENTH, TWO THOUSAND ONE SCHOLARSHIP FUND. 1. THERE IS HEREBY ESTABLISHED, IN THE JOINT CUSTODY OF THE COMMISSIONER OF TAXATION AND FINANCE AND THE COMPTROLLER, A SPECIAL FUND TO BE KNOWN AS THE SEPTEMBER ELEVENTH, TWO THOUSAND ONE SCHOLARSHIP FUND.
- 2. SUCH FUND SHALL CONSIST OF ALL REVENUES RECEIVED PURSUANT TO THE PROVISIONS OF SECTION FOUR HUNDRED FOUR-X OF THE VEHICLE AND TRAFFIC LAW AND ALL OTHER MONEYS APPROPRIATED, CREDITED, OR TRANSFERRED THERETO FROM ANY OTHER FUND OR SOURCE PURSUANT TO LAW. NOTHING CONTAINED IN THIS SECTION SHALL PREVENT THE STATE FROM RECEIVING GRANTS, GIFTS, OR BEQUESTS FOR THE PURPOSES OF THE FUND, AS DEFINED IN THIS SECTION, AND DEPOSITING THEM INTO THE FUND ACCORDING TO LAW.
- 3. MONIES OF THE FUND SHALL BE EXPENDED ONLY FOR HIGHER EDUCATION OF VICTIMS WHO LOST AN IMMEDIATE FAMILY MEMBER AS A RESULT OF THE SEPTEMBER 24 ELEVENTH, TWO THOUSAND ONE TERRORIST ATTACKS IN NEW YORK.
- 4. MONIES SHALL BE PAYABLE FROM THE FUND ON THE AUDIT AND WARRANT OF THE COMPTROLLER ON VOUCHERS APPROVED AND CERTIFIED BY THE COMMISSIONER OF EDUCATION.
- 5. TO THE EXTENT POSSIBLE, THE COMMISSIONER OF EDUCATION SHALL ENSURE THAT ALL MONIES RECEIVED DURING A FISCAL YEAR ARE EXPENDED PRIOR TO THE OF THAT FISCAL YEAR.
- 31 S 3. This act shall take effect on the one hundred eightieth day after 32 it shall have become a law.
