AN ACT to amend the civil rights law and the civil practice law and rules, in relation to the accrual of a cause of action for a declaratory judgment of libel or slander of a decedent

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The civil rights law is amended by adding a new section 2 78-a to read as follows:

CAUSE OF ACTION FOR A DECLARATORY JUDGMENT OF LIBEL OR SLAN-78-A. DER OF A DECEDENT. A CAUSE OF ACTION FOR A DECLARATORY JUDGMENT 5 TO THE SPOUSE, PARENT OR CHILD OF A DECEDENT AS A RESULT OF A LIBEL OR SLANDER THAT OCCURRED AFTER, BUT WITHIN FIVE YEARS OF THE 7 ANY SUCH ACTION MUST BE COMMENCED WITHIN ONE YEAR DECEDENT'S DEATH. 8 PURSUANT TO SECTION TWO HUNDRED FIFTEEN OF THE CIVIL PRACTICE 9 THE COMMENCEMENT OF SUCH ACTION, THE PLAINTIFF MUST PRIOR TO 10 REOUEST A RETRACTION OF SUCH ALLEGED LIBELOUS OR SLANDEROUS STATEMENTS A REGISTERED OR CERTIFIED LETTER, RETURN RECEIPT REQUESTED FROM THE 11 12 DEFENDANT. IN SUCH LETTER, THE PLAINTIFF MUST SET FORTH, 13 THEIR OBJECTIONS TO THE ALLEGED LIBELOUS OR SLANDEROUS STATE-NO ACTION MAY BE COMMENCED UNTIL THIRTY DAYS AFTER SUCH LETTER 14 MENTS. 15 RECEIVED. IF THE DEFENDANT IS A NEWSPAPER OR A RADIO OR TELEVISION STATION, A COPY OF SUCH LETTER MUST ALSO BE SENT TO ONE NATIONAL 16 SERVICE AND ONE NEWSPAPER OF GENERAL CIRCULATION IN THE SAME COUNTY AS 17 SUCH ALLEGED LIBELOUS OR SLANDEROUS STATEMENTS WERE PUBLISHED OR SPOKEN. 18 19 NOTWITHSTANDING ANY OTHER PROVISION OF LAW, TAPE RECORDINGS ${\tt WITH}$

S 2. Section 215 of the civil practice law and rules is amended by adding a new subdivision 9 to read as follows:

- 9. AN ACT FOR A DECLARATORY JUDGMENT OF LIBEL OR SLANDER OF A DECEDENT PURSUANT TO SECTION SEVENTY-EIGHT-A OF THE CIVIL RIGHTS LAW.
- S 3. This act shall take effect immediately and shall only apply to a libel or slander made on or after such effective date.
