AN ACT to amend the New York city civil court act, in relation to the election of additional judges of the civil court of the city of New York

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 2 of section 102-a of the New York city civil 2 court act, as added by chapter 511 of the laws of 1993, is amended to 3 read as follows:

4 2. The twenty-five additional judges of the civil court of the city of 5 New York authorized on June first, nineteen hundred sixty-eight by chapб nine hundred eighty-seven of the laws of nineteen hundred sixtyter 7 eight shall be elected in and from the residents of the following counin the indicated numbers: from the county of New York, seven; from 8 ties 9 the county of Kings, seven; from the county of Queens, six; from the county of Bronx, four; and from the county of Richmond, one. Such addi-10 tional judges shall receive the same compensation as the existing judges 11 of the civil court of the city of New York. The eleven additional judges 12 of the civil court of the city of New York authorized by [this] 13 section 14 SEVEN OF CHAPTER FIVE HUNDRED OF THE LAWS OF NINETEEN HUNDRED EIGHTY-TWO shall be [chosen by the electors of the counties included within the 15 16 city of New York from districts within such counties as shall be established by law] ELECTED IN AND FROM THE RESIDENTS OF THE FOLLOWING COUN-17 TIES IN THE INDICATED NUMBERS: FROM THE COUNTY OF NEW YORK, 18 ONE; FROM KINGS, THREE; FROM THE COUNTY OF QUEENS, FOUR; FROM THE COUNTY OF 19 THE 20 COUNTY OF BRONX, TWO; AND FROM THE COUNTY OF RICHMOND, ONE. SUCH ADDI-21 TIONAL JUDGES SHALL RECEIVE THE SAME COMPENSATION AS THE EXISTING JUDGES 22 OF THE CIVIL COURT OF THE CITY OF NEW YORK.

This act shall take effect immediately; provided, however, that 2 in accordance with subdivision a of section 15 of article 6 of the 3 constitution, the additional judgeships of the civil court of the city 4 of New York affected by the provisions of this act first shall be filled 5 at the general election to be held in November 2014 for a term to 6 commence January 1, 2015.
