AN ACT to amend the penal law, in relation to an assault of emergency department personnel while such employee is performing an assigned duty in, or directly related to such hospital emergency department

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 3 of section 120.05 of the penal law, as
2 amended by chapter 377 of the laws of 2012, is amended to read as
3 follows:
4 3. With intent to prevent a peace officer, a police officer, regis-
5 tered nurse, licensed practical nurse, sanitation enforcement agent, New
6 York city sanitation worker, a firefighter, including a firefighter
7 acting as a paramedic or emergency medical technician administering
8 first aid in the course of performance of duty as such firefighter, an
9 emergency medical service paramedic or emergency medical service techni-
10 cian, or medical or related personnel in a hospital emergency department
11 PERFORMING ANY PROFESSIONAL-RELATED DUTIES, a city marshal, a traffic
12 enforcement officer or traffic enforcement agent, from performing a
13 lawful duty, by means including releasing or failing to control an
14 animal under circumstances evincing the actor's intent that the animal
15 obstruct the lawful activity of such peace officer, police officer,
16 registered nurse, licensed practical nurse, sanitation enforcement
17 agent, New York city sanitation worker, firefighter, paramedic, techni-
18 cian, city marshal, traffic enforcement officer or traffic enforcement
19 agent, he or she causes physical injury to such peace officer, police
20 officer, registered nurse, licensed practical nurse, sanitation enforce-
21 ment agent, New York city sanitation worker, firefighter, paramedic,
22 technician or medical or related personnel in a hospital emergency
23 department WHILE SUCH EMPLOYEE IS PERFORMING AN ASSIGNED DUTY IN, OR

5 11. With intent to cause physical injury to a train operator, ticket
6 inspector, conductor, signalperson, bus operator or station agent
7 employed by any transit agency, authority or company, public or private,
8 whose operation is authorized by New York state or any of its political
9 subdivisions, a city marshal, a traffic enforcement officer, traffic
10 enforcement agent, sanitation enforcement agent, New York city sanita-
11 tion worker, registered nurse or licensed practical nurse, TECHNICIAN OR
12 MEDICAL OR RELATED PERSONNEL IN A HOSPITAL EMERGENCY DEPARTMENT WHILE
13 SUCH EMPLOYEE IS PERFORMING AN ASSIGNED DUTY IN, OR DIRECTLY RELATED TO
14 SUCH HOSPITAL EMERGENCY DEPARTMENT he or she causes physical injury to
15 such train operator, ticket inspector, conductor, signalperson, bus
16 operator or station agent, city marshal, traffic enforcement officer,
17 traffic enforcement agent, registered nurse or licensed practical nurse,
18 sanitation enforcement agent or New York city sanitation worker, while
19 such employee is performing an assigned duty on, or directly related to,
20 the operation of a train or bus, or such city marshal, traffic enforce-
21 ment officer, traffic enforcement agent, registered nurse or licensed
22 practical nurse, sanitation enforcement agent or New York city sanita-
23 tion worker, is performing an assigned duty OR TECHNICIAN OR MEDICAL OR
24 RELATED PERSONNEL IN A HOSPITAL EMERGENCY DEPARTMENT WHILE SUCH EMPLOYEE
25 IS PERFORMING AN ASSIGNED DUTY IN, OR DIRECTLY RELATED TO SUCH HOSPITAL
26 EMERGENCY DEPARTMENT.

27 S 3. This act shall take effect on the first of November next succeed-
28 ing the date on which it shall have become a law.
