Introduced by Sens. RANZENHOFER, DeFRANCISCO, GOLDEN, MAZIARZ -- read twice and ordered printed, and when printed to be committed to the Committee on Alcoholism and Drug Abuse

AN ACT to amend the alcoholic beverage control law, the penal law and the vehicle and traffic law, in relation to authorizing courts to suspend a driver's license where the holder fails to appear before the court, pay a fine, complete an alcohol awareness program or complete community service within the period of time established by such court

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. Subdivision 3 of section 65-c of the alcoholic beverage  
2 control law, as amended by chapter 137 of the laws of 2001, is amended  
3 to read as follows:  
4     3. Any person who unlawfully possesses an alcoholic beverage with  
5 intent to consume may be summoned before and examined by a court having  
6 jurisdiction of that charge; provided, however, that nothing contained  
7 herein shall authorize, or be construed to authorize, a peace officer as  
8 defined in subdivision thirty-three of section 1.20 of the criminal  
9 procedure law or a police officer as defined in subdivision thirty-four  
10 of section 1.20 of such law to arrest a person who unlawfully possesses  
11 an alcoholic beverage with intent to consume. If a determination is made  
12 sustaining such charge the court may impose a fine not exceeding fifty  
13 dollars and/or completion of an alcohol awareness program established  
14 pursuant to section 19.25 of the mental hygiene law and/or an appropri-  
15 ate amount of community service not to exceed thirty hours. IN ADDITION  
16 TO ANY FINE, ALCOHOL AWARENESS PROGRAM AND/OR COMMUNITY SERVICE IMPOSED  
17 BY THE COURT PURSUANT TO THIS SECTION, THE COURT MAY SUSPEND THE DRIV-  
18 ER'S LICENSE OF ANY PERSON WHO FAILS TO APPEAR BEFORE THE COURT, PAY A  
19 FINE, COMPLETE AN ALCOHOL AWARENESS PROGRAM OR COMPLETE COMMUNITY  
20 SERVICE PURSUANT TO THIS SECTION WITHIN THE PERIOD OF TIME ESTABLISHED

1 BY SUCH COURT. SUCH SUSPENSION SHALL BE MADE UPON NOTICE TO SUCH PERSON  
2 AND SHALL REMAIN IN EFFECT UNTIL SUCH PERSON APPEARS IN COURT, SUCH FINE  
3 HAS BEEN PAID OR SUCH PROGRAM OR COMMUNITY SERVICE HAS BEEN COMPLETED TO  
4 THE SATISFACTION OF THE COURT.

5 S 2. Section 221.05 of the penal law, as added by chapter 360 of the  
6 laws of 1977, is amended to read as follows:

7 S 221.05 Unlawful possession of marihuana.

8 A person is guilty of unlawful possession of marihuana when he OR SHE  
9 knowingly and unlawfully possesses marihuana.

10 Unlawful possession of marihuana is a violation punishable only by a  
11 fine of not more than one hundred dollars. However, where the defendant  
12 has previously been convicted of an offense defined in this article or  
13 article [220] TWO HUNDRED TWENTY of this chapter, committed within the  
14 three years immediately preceding such violation, it shall be punishable  
15 (a) only by a fine of not more than two hundred dollars, if the defend-  
16 ant was previously convicted of one such offense committed during such  
17 period, and (b) by a fine of not more than two hundred fifty dollars or  
18 a term of imprisonment not in excess of fifteen days or both, if the  
19 defendant was previously convicted of two such offenses committed during  
20 such period. IN ADDITION TO ANY FINE IMPOSED BY THE COURT PURSUANT TO  
21 THIS SECTION, THE COURT MAY SUSPEND THE DRIVER'S LICENSE OF ANY PERSON  
22 WHO FAILS TO APPEAR BEFORE THE COURT OR PAY A FINE PURSUANT TO THIS  
23 SECTION WITHIN THE PERIOD OF TIME ESTABLISHED BY SUCH COURT. SUCH  
24 SUSPENSION SHALL BE MADE UPON NOTICE TO SUCH PERSON AND SHALL REMAIN IN  
25 EFFECT UNTIL SUCH PERSON APPEARS IN COURT OR SUCH FINE HAS BEEN PAID TO  
26 THE SATISFACTION OF THE COURT.

27 S 3. Paragraph k of subdivision 3 of section 510 of the vehicle and  
28 traffic law, as amended by chapter 124 of the laws of 1992, is amended  
29 and two new paragraphs l and m are added to read as follows:

30 k. for a period of up to ninety days because of the conviction of the  
31 holder of the offenses of menacing as defined in section 120.15 of the  
32 penal law, where such offense was committed against a traffic enforce-  
33 ment agent employed by the city of New York or the city of Buffalo while  
34 such agent was enforcing or attempting to enforce the traffic regu-  
35 lations of such city[.];

36 L. FOR FAILING TO APPEAR BEFORE THE COURT OR PAY A FINE OR TO COMPLETE  
37 AN ALCOHOL AWARENESS PROGRAM OR COMPLETE COMMUNITY SERVICE IMPOSED BY  
38 THE COURT PURSUANT TO SUBDIVISION THREE OF SECTION SIXTY-FIVE-C OF THE  
39 ALCOHOLIC BEVERAGE CONTROL LAW;

40 M. FOR FAILING TO APPEAR BEFORE THE COURT OR PAY A FINE IMPOSED BY THE  
41 COURT PURSUANT TO SECTION 221.05 OF THE PENAL LAW.

42 S 4. Paragraph (a) of subdivision 4-a of section 510 of the vehicle  
43 and traffic law, as added by section 10 of part J of chapter 62 of the  
44 laws of 2003, is amended to read as follows:

45 (a) Upon receipt of a court notification of the failure of a person to  
46 appear within sixty days of the return date or new subsequent adjourned  
47 date, pursuant to an appearance ticket charging said person with a  
48 violation of any of the provisions of this chapter (except one for park-  
49 ing, stopping, or standing), of any violation of the tax law or OF  
50 SUBDIVISION THREE OF SECTION SIXTY-FIVE-C OF THE ALCOHOLIC BEVERAGE  
51 CONTROL LAW OR OF SECTION 221.05 OF THE PENAL LAW OR of the transpor-  
52 tation law regulating traffic or of any lawful ordinance or regulation  
53 made by a local or public authority, relating to traffic (except one for  
54 parking, stopping, or standing) or the failure to pay a fine imposed by  
55 a court the commissioner or his or her agent may suspend the driver's  
56 license or privileges of such person pending receipt of notice from the

1 court that such person has appeared in response to such appearance tick-  
2 et or has paid such fine. Such suspension shall take effect no less than  
3 thirty days from the day upon which notice thereof is sent by the  
4 commissioner to the person whose driver's license or privileges are to  
5 be suspended. Any suspension issued pursuant to this paragraph shall be  
6 subject to the provisions of paragraph (j-1) of subdivision two of  
7 section five hundred three of this [chapter] TITLE.

8 S 5. This act shall take effect on the first of January next succeed-  
9 ing the date on which it shall have become a law.
