- AN ACT to amend the vehicle and traffic law, in relation to the registration of snowmobiles used solely for the purpose of hunting, fishing or trapping

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 2222 of the vehicle and traffic law is amended by 2 adding a new subdivision 2-a to read as follows:

THE COMMISSIONER IS AUTHORIZED 3 TO REGISTER A SNOWMOBILE AS A 2-A. 4 NON-TRAIL SNOWMOBILE WHICH SHALL BE USED SOLELY FOR THE PURPOSE OF GAIN-5 ING ACCESS TO HUNTING, FISHING AND TRAPPING AREAS. SUCH REGISTRATION SHALL BE COMPRISED OF A BLAZE ORANGE BACKGROUND WITH BLACK LETTERING. 6 7 THE FEE FOR THE REGISTRATION OF A SNOWMOBILE AS A NON-TRAIL SNOWMOBILE 8 AND EACH RENEWAL THEREOF SHALL BE TWENTY-FIVE DOLLARS, FIFTEEN DOLLARS 9 OF WHICH SHALL BE DEPOSITED INTO THE SNOWMOBILE TRAIL DEVELOPMENT AND MAINTENANCE FUND SET FORTH IN SECTION 21.07 OF THE PARKS, RECREATION AND 10 11 HISTORIC PRESERVATION LAW.

12 S 2. Section 2230 of the vehicle and traffic law is amended by adding 13 a new subdivision 3 to read as follows:

14 3. ANY PERSON WHO VIOLATES THE PROVISIONS OF SUBDIVISION TWO-A OF SECTION TWENTY-TWO HUNDRED TWENTY-TWO OF THIS ARTICLE SHALL BE GUILTY OF 15 FIVE HUNDRED DOLLARS FOR EACH 16 A VIOLATION PUNISHABLE BY A FINE OF OFFENSE, OF WHICH FOUR HUNDRED DOLLARS OF SUCH FINE SHALL BE 17 DEPOSITED 18 THE SNOWMOBILE TRAIL DEVELOPMENT AND MAINTENANCE FUND SET FORTH IN IN 19 SECTION 21.07 OF THE PARKS, RECREATION AND HISTORIC PRESERVATION LAW. IN 20 ADDITION TO SUCH FINE, ANY SECOND OR SUBSEQUENT OFFENSE WITHIN A FIVE YEAR PERIOD SHALL RESULT IN THE SUSPENSION OF ALL LICENSES SET FORTH IN 21 SECTION 11-0701 OF THE ENVIRONMENTAL CONSERVATION LAW HELD 22 ΒY SUCH 23 PERSON FOR A PERIOD OF ONE YEAR.

24 S 3. This act shall take effect immediately.
