AN ACT to amend the public health law, in relation to temporary approval of certain programs operated pursuant to the federal special supplemental nutrition program for women, infants and children

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The public health law is amended by adding a new section 2 2507 to read as follows:

3 2507. FEDERAL SPECIAL SUPPLEMENTAL NUTRITION PROGRAM FOR WOMEN, S 4 INFANTS AND CHILDREN. ANY ELIGIBLE INSTITUTION APPLYING TO BE AUTHOR-5 IZED TO PARTICIPATE IN THE FEDERAL SPECIAL SUPPLEMENTAL NUTRITION б PROGRAM FOR WOMEN, INFANTS AND CHILDREN AT A PARTICULAR SITE, WHICH HAS 7 APPROVAL TO PARTICIPATE AT ANOTHER SITE AND HAS NOT BEEN DEFI-RECEIVED 8 CIENT IN ITS PARTICIPATION AS SPECIFIED IN FEDERAL LAW, RULE OR REGU-SHALL BE ISSUED TEMPORARY APPROVAL TO BE AUTHORIZED TO PARTIC-9 LATION, IPATE IN THE FEDERAL SPECIAL SUPPLEMENTAL NUTRITION PROGRAM FOR WOMEN, 10 AND CHILDREN AT THE SITE FOR WHICH THE APPLICATION HAS BEEN 11 INFANTS SUBMITTED TO THE COMMISSIONER. THE COMMISSIONER OR 12 THE COMMISSIONER'S 13 AGENT SHALL ISSUE THE APPLICANT A TEMPORARY APPROVAL TO PARTICIPATE AT A PURSUANT TO THIS SECTION, WITHIN FOURTEEN DAYS OF THE 14 PARTICULAR SITE, RECEIPT OF A COMPLETED APPLICATION. EACH TEMPORARY APPROVAL SHALL BE 15 16 VALID UNTIL THE COMMISSIONER EITHER APPROVES OR DISAPPROVES THE PROPOSED 17 APPLICATION OF THE APPLICANT. THIS SECTION SHALL NOT APPLY WHERE IT 18 WOULD BE CONTRARY TO FEDERAL REGULATIONS OR WOULD JEOPARDIZE FEDERAL FINANCIAL PARTICIPATION. 19

20 S 2. This act shall take effect immediately.
