- AN ACT to amend the penal law, in relation to the payment of restitution to volunteer fire companies in certain instances

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Subdivision 10 of section 60.27 of the penal law, as added 1 by chapter 310 of the laws of 1996, is amended to read as follows: 2 10. If the offense of which a person is convicted is defined in section 150.10, 150.15 or 150.20 of this chapter, and no other victim 3 4 5 who is a person is seeking restitution in the case, the term "victim" as 6 used in this section, in addition to its ordinary meaning, shall mean 7 any municipality OR VOLUNTEER FIRE COMPANY which has expended funds or 8 expend funds for the purpose of restoration, rehabilitation or will 9 clean-up of the site of the arson. Any restitution which may be required to be made to a municipality OR VOLUNTEER FIRE COMPANY pursuant to this 10 section shall be limited to the amount of funds reasonably expended or 11 to be expended for the purpose of restoration, rehabilitation or clean-12 up of the site of the arson, less the amount of any funds which have 13 been or will be recovered from any other source, and shall not include a 14 15 designated surcharge pursuant to subdivision eight of this section. Any 16 municipality OR VOLUNTEER FIRE COMPANY seeking restitution pursuant to 17 this section shall file with the court, district attorney and defense counsel an affidavit stating that the funds reasonably expended or to be 18 expended for which restitution is being sought have not been and will 19
