AN ACT to amend the vehicle and traffic law, the state finance law and the social services law, in relation to establishing Jacobs' fund to assist victims of drunk or drug impaired driving who are permanently disabled

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- Section 1. Subdivision 2 of section 503 of the vehicle and traffic law is amended by adding a new paragraph (1) to read as follows:
- 3 (1) WITH RESPECT TO ANY FEE REQUIRED BY THIS SUBDIVISION, THE COLLECT AN ADDITIONAL FEE IN THE AMOUNT OF ONE DOLLAR WHICH 5 SHALL BE USED EXCLUSIVELY TO ASSIST VICTIMS OF DRUNK OR DRUG **IMPAIRED** 6 ADDITION TO SUCH ONE DOLLAR FEE, THE COMPTROLLER SHALL DRIVING. IN 7 CREDIT FIVE HUNDRED DOLLARS ON THE FIRST OF EACH MONTH TO JACOBS' SUPPLEMENT SOCIAL SECURITY DISABILITY AND SOCIAL SECURITY INCOME FOR 8 INDIVIDUALS WHO ARE VICTIMS OF DRUNK OR DRUG IMPAIRED DRIVING, 9 10 PERMANENTLY DISABLED AS A RESULT. MONIES COLLECTED AS A RESULT OF SUCH ADDITIONAL FEE SHALL BE DEPOSITED IN A SPECIAL FUND TO BE KNOWN 11 12 JACOBS' FUND AND MONIES IN SUCH FUND SHALL BE USED EXCLUSIVELY TO ASSIST VICTIMS OF DRUNK OR DRUG IMPAIRED DRIVING AS SET FORTH IN SECTION EIGHT-13 Y-ONE OF THE STATE FINANCE LAW. 14
- 15 S 2. The state finance law is amended by adding a new section 81 to 16 read as follows:
- 17 S 81. JACOBS' FUND. 1. THERE IS HEREBY ESTABLISHED IN THE JOINT CUSTO-18 DY OF THE COMMISSIONER OF TAXATION AND FINANCE AND THE COMPTROLLER, A 19 SPECIAL FUND TO BE KNOWN AS "JACOBS' FUND".
- 20 2. SUCH FUND SHALL CONSIST OF ALL MONEYS RECEIVED BY THE STATE PURSU-21 ANT TO PARAGRAPH (L) OF SUBDIVISION TWO OF SECTION FIVE HUNDRED THREE OF 22 THE VEHICLE AND TRAFFIC LAW AND ALL OTHER GRANTS, BEQUESTS OR OTHER

MONEYS APPROPRIATED, CREDITED OR TRANSFERRED THERETO FROM ANY OTHER FUND OR SOURCE PURSUANT TO LAW.

- 3. MONEYS IN THE FUND SHALL BE KEPT SEPARATE AND APART AND SHALL NOT BE COMMINGLED WITH ANY OTHER MONEYS IN THE CUSTODY OF THE COMMISSIONER OF TAXATION AND FINANCE AND THE COMPTROLLER.
- 4. MONEYS OF THE FUND, FOLLOWING APPROPRIATION BY THE LEGISLATURE, SHALL BE AVAILABLE TO THE DEPARTMENT OF SOCIAL SERVICES AND SHALL BE EXPENDED BY SUCH DEPARTMENT TO ASSIST VICTIMS OF DRUNK OR DRUG IMPAIRED DRIVING PURSUANT TO THE PROVISIONS OF SUBDIVISION NINE OF SECTION TWENTY OF THE SOCIAL SERVICES LAW.
- S 3. Section 20 of the social services law is amended by adding a new subdivision 9 to read as follows:
- 9. THE OFFICE OF TEMPORARY AND DISABILITY ASSISTANCE SHALL, IN COOPERATION WITH LOCAL SOCIAL SERVICES DISTRICTS AND APPROPRIATE FEDERAL AGENCIES DEVELOP A PROGRAM TO ASSIST VICTIMS OF DRUNK OR DRUG IMPAIRED DRIVING WHO ARE PERMANENTLY DISABLED AND UNABLE TO WORK. SUCH PROGRAM SHALL BE FUNDED BY FUNDS MADE AVAILABLE FROM JACOBS' FUND, AS ESTABLISHED BY SECTION EIGHTY-ONE OF THE STATE FINANCE LAW. APPLICATION FOR SUCH FUNDS SHALL BE MADE IN A MANNER AND FORM AS DETERMINED BY SUCH OFFICE. THE OFFICE OF TEMPORARY AND DISABILITY ASSISTANCE IS HEREBY AUTHORIZED AND DIRECTED TO PROMULGATE RULES AND REGULATIONS NECESSARY TO CARRY OUT THE PROVISIONS OF THIS SUBDIVISION.
- S 4. This act shall take effect on the one hundred eightieth day after it shall have become a law, provided, however, that effective immediately, the addition, amendment and/or repeal of any rule or regulation necessary for the implementation of this act on its effective date is authorized to be made and completed on or before such date.
