AN ACT to amend the public health law, in relation to licensing and registration for funeral directors

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Paragraph (a) of subdivision 2 of section 3421 of the
2 public health law, as amended by chapter 534 of the laws of 1983, is
3 amended to read as follows:

4 (a) is a citizen of the United States or [an alien lawfully admitted
5 for permanent residence] HAS LAWFUL ENTRY in the United States;

6 S 2. Subdivision 1 of section 3429 of the public health law is amended
7 by adding a new paragraph (f) to read as follows:

8 (F) "ACCREDITED SCHOOL" MEANS A POSTSECONDARY EDUCATIONAL INSTITUTION
9 AND PROGRAMS THAT ARE ACCREDITED BY AN ACCREDITING AGENCY OR STATE
10 APPROVAL AGENCY RECOGNIZED BY THE UNITED STATES SECRETARY OF EDUCATION
11 AS A "RELIABLE AUTHORITY AS TO THE QUALITY OF POSTSECONDARY EDUCATION"
12 WITHIN THE MEANING OF THE HIGHER EDUCATION ACT OF 1965, AS AMENDED
13 (HEA).

14 S 3. Paragraph (b) of subdivision 4 of section 3429 of the public
15 health law, as added by chapter 529 of the laws of 2000, is amended to
16 read as follows:

17 (b) A registered provider which is required to obtain prior approval
18 of courses shall submit to the department a written description of each
19 course for which approval is requested, at least sixty days prior to the
20 first date the course is to be offered. If the department does not
21 disapprove the proposed course within ninety days of its receipt of the
22 written description and request for approval, the course shall be
23 considered approved provisionally for six months. Following the six
24 months of provisional approval, the department may make a final determi-
25 nation disapproving the course. Notwithstanding such determination,

1 however, any individuals licensed pursuant to section three thousand
2 four hundred twenty-eight of this title shall receive full continuing
3 education credit for any course taken during the period of provisional
4 approval to fulfill the requirements of this section. AN ACCREDITED
5 SCHOOL FOR FUNERAL DIRECTORS APPROVED UNDER SECTION THREE THOUSAND FOUR
6 HUNDRED TWENTY-FIVE OF THIS TITLE AND REGISTERED AS A PROVIDER ACCORDING
7 TO THIS SECTION SHALL BE EXEMPT FROM REQUESTING PRIOR APPROVAL OF COURSES
8 OFFERED IN ACCORDANCE WITH THIS SECTION.

9 S 4. This act shall take effect immediately.
