AN ACT to amend the public health law, in relation to establishing certain substances as schedule I stimulants controlled substances

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- Section 1. Paragraphs 9 and 10 of subdivision (f) of schedule I of section 3306 of the public health law, as added by chapter 130 of the laws of 2011, are amended and fourteen new paragraphs 11 through 24 are added to read as follows:
- 5 (9) 4-METHYL-N-METHYLCATHINONE OR 4-Methylmethcathinone, also known as 6 Mephedrone.
- 7 (10) 3,4-METHYLENEDIOXYPYROVALERONE OR Methylenedioxypyrovalerone, 8 also known as MDPV.
- 9 (11) 3,4-METHYLENEDIOXY-N-METHYLCATHINONE (SOME OTHER NAMES: METHY-10 LONE).
- 11 (12) 4-METHOXYMETHCATHINONE.
 - (13) 3-FLUOROMETHCATHINONE.
- 13 (14) 4-FLUOROMETHCATHINONE.

- 15 (16) 2-(2,5-DIMETHOXY-4-ETHYLPHENYL)ETHANAMINE (2C-E).
