- AN ACT to amend chapter 704 of the laws of 1991, amending the arts and cultural affairs law and chapter 912 of the laws of 1920 relating to the regulation of boxing and wrestling relating to tickets to places of entertainment, and chapter 151 of the laws of 2010, amending the arts and cultural affairs law relating to resale of tickets to places of entertainment, in relation to extending the effectiveness of the provisions thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 4 of chapter 704 of the laws of 1991, amending the 2 arts and cultural affairs law and chapter 912 of the laws of 1920 relat-3 ing to the regulation of boxing and wrestling relating to tickets to 4 places of entertainment, as amended by chapter 28 of the laws of 2012, 5 is amended to read as follows:

б This act shall take effect on the sixtieth day after it shall S 4. 7 have become a law, provided, chapter 61 of the laws of 2007 shall not 8 take effect with respect to the issuance of licenses or certificates 9 under this article by the secretary of state or department of state 10 until January 1, 2008 and regulation under this article by the commis-11 sioners of licenses of the political subdivisions of the state shall continue through December 31, 2007, and shall remain in full force and 12 effect only until and including May 14, [2013] 2014 when such act shall 13 repealed and when, notwithstanding any other provision of law, the 14 be provisions of article 25 of title G of the arts and cultural affairs 15 repealed by such act, shall be reinstituted; provided further that 16 law, 17 section 25.11 of the arts and cultural affairs law, as added by section 18 one of this act, shall survive such repeal date. 1 article 25 of the arts and cultural affairs law, as added by this act, 2 shall not apply to tickets printed prior to enactment of such article so 3 long as notice of the higher maximum premium price and prohibition of 4 sales within one thousand five hundred feet from the physical structure 5 of the place of entertainment, where applicable, is prominently 6 displayed at the point of sale and at such place of entertainment.

7 S 2. Section 11 of chapter 151 of the laws of 2010, amending the arts 8 and cultural affairs law relating to resale of tickets to places of 9 entertainment, as amended by chapter 28 of the laws of 2012, is amended 10 to read as follows:

11 S 11. Notwithstanding the provisions of article 5 of the general 12 construction law, if this act shall take effect after May 15, 2010, the 13 provisions of article 25 of the arts and cultural affairs law, except 14 section 25.11 are hereby revived and shall continue in full force and 15 effect as they existed on May 15, 2010 through May 14, [2013] 2014, when 16 upon such date such provisions shall expire and be deemed repealed. 17 S 3. This act shall take effect immediately.
